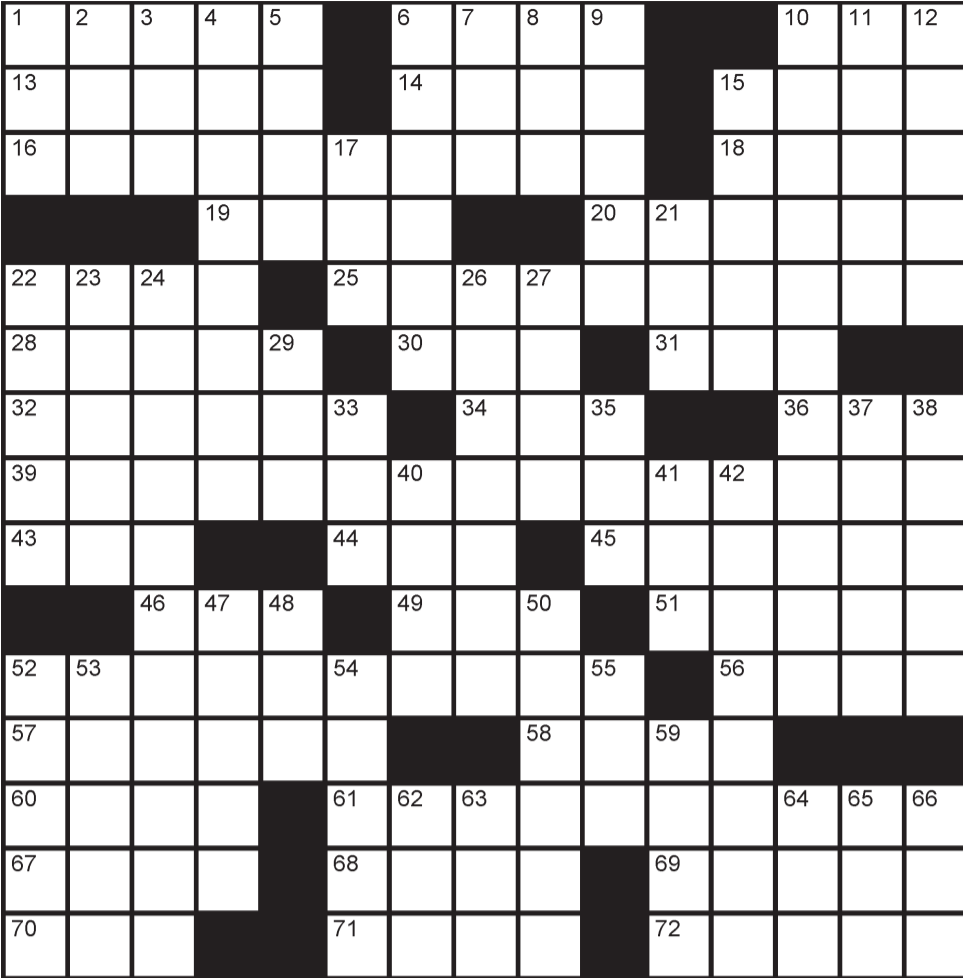

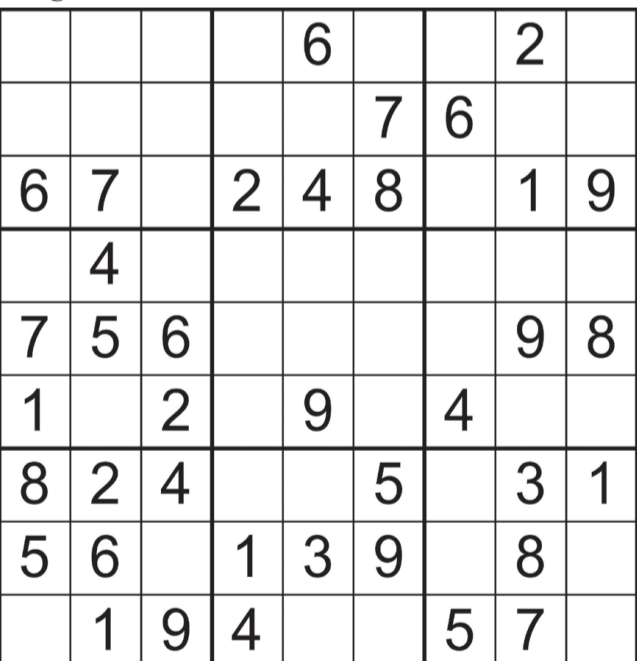

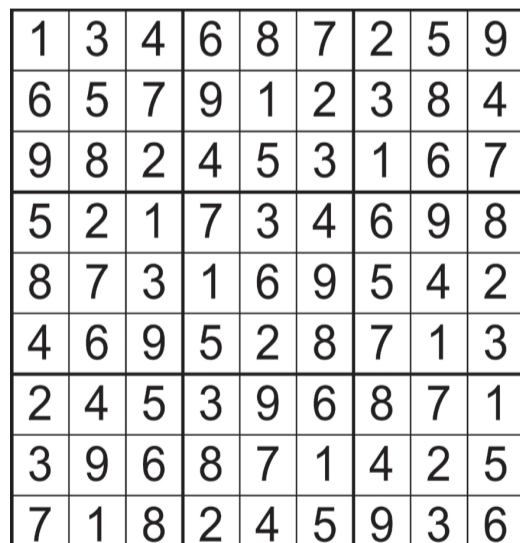
**King Classic Sudoku**
