

# Grant County grand jury hands down 12 indictments

On Wednesday, Oct. 9, the Grant County grand jury handed down 12 indictments.

• Scott Emmons, 46, was indicted for robbery (first degree), fleeing or evading police (second degree), resisting arrest and assault (fourth degree). The alleged incidents took place Aug. 29.

• Timothy W. Sexton, 63, was indicted for strangulation (first degree) and terroristic threatening (third degree). The alleged incidents occurred Sept. 19.

• Mary Barnett, 27, was indicted for theft of identity of another without consent, failure of nonowner to maintain required insurance (first offense), operating on sus-
