Cammack wins 2 events

NEW CASTLE The Owen County High School boys track and field squad placed third in the North Central Kentucky Track Conference Championships, which were held on April 16 at Henry County High School.

The Rebels finished with 95 points, behind first-place Western Hills (118 points) and Williamstown (105). There were 10 boys teams and 10 girls teams compet-

Owen County's Tyler Cammack won both the 1600-meter run and the 3200-meter run, and teammate Gabe Carter placed second in the 400meter dash.

In the field events, Rebel standout Griffin Gentry won the shot put, with teammate Adler Smith placing third.

Talon Wilson placed second in the long jump, and teammate Sidi Cheikhahmed placed fourth. Cheikhahmed also placed sixth in the 100-meter dash and the 200-meter dash, with Carter and Wilson placing fifth and seventh in the 200-meter dash, respectively.
