

SUMMARY OF PROCEDURES AND FINDINGS

#### AGREED-UPON PROCEDURES OF THE **BOYLE COUNTY SHERIFF**

For The Period January 1, 2024 Through December 31, 2024

The Boyle County Sheriff applied for and received approval from the Auditor of Public Accounts (APA) to obtain an Agreed-Upon Procedures (AUP) engagement for calendar year 2024 in accordance with KRS 43.070(1)(c). AUP reports present the procedures performed and the results of those procedures, called findings. This summary is intended to present findings for which an exception (an instance of noncompliance with the criteria) was identified during the AUP engagement.

During the AUP engagement of the Boyle County Sheriff, the following exceptions were noted:

- The sheriff performed monthly bank reconciliations for all accounts except for the restitution and general donation accounts.
- All disbursements tested agreed to cancelled checks, except for two transactions in the K-9 donation account totaling \$3,000. All disbursements tested agreed to supporting documentation and were for official business except for four credit card purchases totaling \$321 that did not have supporting documentation. The state advancement was repaid.
- The sheriff's maximum salary order for deputies was overspent by \$189,481

Findings related to procedures for which there were no exceptions identified, and official responses to exceptions are not included in the summary above but can be found in the full report. A copy of this report is available on the Auditor of Public Accounts' website at <u>auditor.ky.gov</u>.






