

ORDINANCE RE-ZONING THE PROPERTY LOCATED AT 2455 NEW BOWLING GREEN ROAD, GLASGOW, KENTUCKY, CONTAINING 4.434 ACRES, MORE OR LESS, FROM I-1 (LIGHT INDUSTRIAL DISTRICT) TO B-3 (HIGHWAY SERVICE BUSINESS DISTRICT) CLASSIFICATION. IT APPEARING THAT: 1. Brad Miles, Applicant, for and on behalf of Owner, Newcomb Oil Co., LLC, has requested a zoning change for the property located at 2455 New Bowling Green Road, Glasgow, Kentucky, containing 4.434 acres, more or less, in the City of Glasgow, Kentucky, from I-1 (Light Industrial District) to B-3 (Highway Service Business District) Classification. A schematic drawing of said property subject to re-zoning is attached hereto as Exhibit "A" and incorporated herein by reference. 2. A trial-type due process hearing concerning said proposed zoning change was held on January 21, 2025, at 7:00 p.m., by the Joint City-County Planning and Zoning Commission, resulting in the unanimous recommendation by the Commission that the property hereinafter described be re-zoned from I-1 (Light Industrial District) to B-3 (Highway Service Business District) Classification. 3. Copies of the findings and recommendations of the Joint City-County Planning and Zoning Commission have been forwarded to the Glasgow City Council, are hereby adopted by the Glasgow City Council, and are attached to this Ordinance as Exhibit "B", and incorporated herein by reference. **NOW, THEREFORE, BE IT HEREBY ORDAINED** by the City of Glasgow as follows: **Section No. 1:** The findings and recommendations of the Joint City-County Planning and Zoning Commission, copies of which are attached hereto as Exhibit "B", are hereby approved in all respects. **Section No. 2:** The zoning for the property located at 2455 New Bowling Green Road, Glasgow, Kentucky, containing 4.434 acres, more or less, in the City of Glasgow, Kentucky, shall be, and hereby is, changed from I-1 (Light Industrial District) to B-3 (Highway Service Business District) Classification, the real property covered by this Ordinance being more particularly described in Exhibit "A", and incorporated herein by reference. **Section No. 3:** All future development of this property shall comply with the requirements of the Development Plan Ordinance, adopted by the Glasgow City Council on December 30, 1991. **Section No. 4:** This ordinance shall take effect upon its passage and publication according to law.
