Terrence Miles, 37, was initially arrested and charged with two counts of first-degree criminal abuse, second-degree wanton endangerment, and first-degree official misconduct by the Horse Cave Police Department.

However, the grand jury returned a true bill in early June with the following counts: second-degree assault, fourth-degree assault (child abuse), second-degree wanton endangerment, first-degree official misconduct, and failure to report child dependency/ neglect/abuse, first offense.

Second-degree assault is a Class C felony, and if convicted, Miles could face five to ten years). The other charges are Class A and B misdemeanors.

The felony charge alleges Miles intentionally caused physical injury to a juvenile by means of a deadly weapon or dangerous instrument by striking the child with a belt that resulted in bruising. The other counts allege he shoved the juvenile into a wall.

A video circulated on social media that has since been deleted; however, the Barren County **Progress obtained** the video shortly after it was posted. The video shows two students holding the juvenile down while Miles removes a belt from the juvenile before handing it to another student, who struck the juvenile with the belt.

Miles resigned from Caverna Independent Schools shortly before his May 2 arrest. Miles' resignation notes regret for his actions and apologies to those involved and the community at large, noting the events that had taken place were "horseplay". He was released from jail after a court appearance on May 5 after a judge approved his bond at 10% of the original \$50,000.

His next court appearance is a pretrial conference scheduled on September 26 at 9 a.m.

An indictment of a person by a grand jury is an accusation only and the person is innocent until and unless proven guilty.

Meanwhile, Caverna High School principal, Frank Beauchamp, confirmed with the Progress earlier in June the hiring of a new head coach, Richard Gatewood. According to statewide news reports, Gatewood also faced criminal charges as a former coach with Moore High School in Louisville in 2023. Charges were dismissed when a grand jury declined an indictment due to lack of evidence. Allegedly, he became physical with a student and slammed him into bleachers and strangled him.

The Barren County Progress has reviewed Gatewood's employment application through an open records request with Caverna and found that Gatewood states "No" when asked, "Have you ever been involuntarily terminated or asked to resign, or resigned in lieu of termination from the employment of another school district?"

He also doesn't list Moore High School in his employment history with any dates for 2023, the year he was reportedly terminated. His resume does list employment referencing Moore **Traditional High** School dating back to 2011-2013; however, nothing noted for 2023. His championship record is impressive with numerous championship wins and over 30 former players having went on to play in college.

Beauchamp declined to comment on June 10 on any of the charges Gatewood was alleged to have committed inside a Jefferson County school and it is unclear if the individuals charged with hiring Gatewood were aware of either the charges or his conflicting employment application as noted above.

Gatewood shared on a local media outlet that he initially declined Caverna's posed by Caverna.

The Progress has reached out to the district with additional questions.

KSP Investigates Barren County Fatal Collision
