Pursuant to KRS 132.027, as amended by the Kentucky General Assembly Extraordinary Session of 1979, the City of Cave City will hold a Public Hearing on September 8, 2025, at 4: 45 p.m. at 103 Duke Street, Cave City, Kentucky, to hear comments from the public regarding proposed 2025 Tax Rate on Real Property.

As required by state law, this notice includes the following information:

CITY OF CAVE CITY, KENTUCKY ORDINANCE NO. 25-6-8

AN ORDINANCE TO REDUCE BLIGHTED, VACATED OR ABANDONED PROPERTIES IN CAVE CITY, KENTUCKY

IT APPEARING THAT:

WHEREAS, especially in the central business district there are several buildings unused, unoccupied and ill-kept, and

WHEREAS, the City is committed to clean up and eliminate blighted, vacated or abandoned properties.

NOW, THEREFORE, BE IT HEREBY ORDAINED, by the City of Cave City, Kentucky, as

follows: Section 1. Abandoned Urban Property is established as a separate classification of real property for the purpose of ad valorem taxation. As used herein, an "Abandoned Urban Property" means any vacant structure or vacant or unimproved lot or parcel of ground located within the boundaries of the City that has been vacal

- or unimproved for a period of at least one (1) year and which: 1. Because it is dilapidated, unsanitary, unsafe, vermin infested or otherwise dangerous to the safety and welfare of persons, is unfit for its intended use;
 - 2. By reason of neglect of lack of maintenance has become a place for the accumulation of trash and debris, or has become infested with rodents or

4. Is located within a development area established under KRS 65.7049, KRS

3. Has been tax delinquent for a period of at least three (3) years; or

65.7051 and KRS 65.7053. Section 2. The rate of ad valorem taxation levied upon Abandoned Urban

Properties is \$.75 on each \$100.00 of assessed value.

A. The Code Enforcement Officer shall determine each year which properties located within the City are Abandoned Urban Properties, and shall prepare and furnish a list thereof to the City Clerk and the Barren County Property Valuation Administrator prior to January 1st of each year.

B. Except as otherwise provided in division (C) of this section, a property classified by the Code Enforcement Officer as Abandoned Urban Property as of January 1st shall be taxed as Abandoned Urban Property for such tax year. If the owner repairs, rehabilitates, or otherwise returns the property to productive use so that the property is not longer Abandoned Urban Property, the owner shall notify the City, by and through it Clerk and if it finds the property is no longer Abandoned Urban Property, it shall notify the Barren County Property Valuation Administrator to strike the property from the list of Abandoned Urban Properties as of the succeeding January 1st.

C. No later than May 1st of each year, the Code Enforcement Officer shall mail, by regular first-class mail, to the owner(s) of each Abandoned Urban Property, as those name(s) are listed in the records of the Property Valuation Administrator, a notice that the property has been classified as Abandoned Urban Property. The owner of any Abandoned Urban Property who believes that the property has been incorrectly classified may appeal said classification to the Code Enforcement Board. Such appeal shall be in writing and shall be made no later than June 1st of that year. The Code Enforcement Board shall afford the owner the opportunity for a hearing. If the Code Enforcement Board finds that the property was incorrectly classified as Abandoned Urban Property, it shall cause the property to be removed from the list of properties so classified.

Section 4. All ordinances or parts thereof in conflict with this ordinance shall be, and hereby are, repealed to the extent of said conflict.

<u>Section 5.</u> Any section or provision of this ordinance that is declared by a Court of appropriate jurisdiction to be invalid for any reason, shall not affect or invalidate the remainder of this ordinance.

Section 6. This ordinance shall take full force and effect upon publication as required by law.
