Fiscal court distributes opioid settlement funds

On Tuesday, Nov 25, the Harrison County Fiscal Court held their final meeting of the month.

-Kicking things off on a celebratory note, Judge Marshall presented Opioid Settlement Grant Funds to recipients in attendance.

"Recently the fiscal court approved the projects that were presented to them," explained Judge Marshall. "Tonight we're ready to present those funds to the recipients. I want to give a big thank you to Brian Canupp, the assistant county attorney, for his leadership on this project.

"It seems that other counties are now modeling the project with the model we used here in Harrison County. So while other counties are still trying to figure out what they're going to do and how they're going to disperse their opioid settlement funds, tonight we're here to give out some money to members of the community."

The Cynthiana-Harrison County Chamber of Commerce received \$5,000 to support their workforce readiness program for individuals

in recovery. Finally, the Harrison County Specialty Court received \$80,000 in support of their project expanding the available services of the Harrison County Drug Court program.

-Judge Marshall made a motion to consider approval to hire Larry Williams as part-time Solid Waste Center employee effective Nov 24, 2025, at \$11.50 per hour, which

-A motion was made to consider approval to pay Melody McClure \$5,302.12 for 2025 Training Incentive, which carried.

-Marshall made a motion to consider approval of Budget for Harrison County Clerk for 2026, which carried. The estimated budget mentioned was \$5,606,625.

-Another motion was made to consider approval of Deputy Clerk's maximum salaries for 2026, which carried. Judge Marshall noted that it's set at \$510,000.

-As a matter of record it was noted Michael Shane Harrington's Harrison Memorial Hospital last day of employment as road

-Another matter of record was noted; Melissa Barlow resigned as a part-time animal shelter worker, effective Nov. 29, 2025.

Committee Reports

-The Road Committee reported that the road department has been working to get trucks ready for the snow and ice of the winter season. It was also noted that they've been working on decorating downtown for the holidays.

Judge Marshall reported the application period for the County/City Bridge Improvement Program is now open, and he implored the court to check bridges in their districts for need of replacement or repair.

Marshall also noted that on Dec. 9, bids will be accepted for the Whitson Road bridge.

-The Animal Shelter Committee 4 rescues/pulls, 14 return to owners, 41 animals in and 34 animals out.

-The Farm & Facilities Committee reported that construction on the new recreation center has slowed down recently. It was noted that masonry appears finished, as well as a majority of three sides.

Clinton Jones left for another job and a new supervisor has taken the project on, Ben Williams.

After conversation with Judy Construction, Judge Marshall explained that a meeting may occur after Thanksgiving to get an update on where everything is at and going.

-The Parks and Recreation Committee reported that JV basketball is about halfway over for the season.

Treasurer Report

-A motion was made to pay the binder claims, which carried. A motion was made to approve transfers, which also carried.

Closing

-Judge Marshall made note of the Dec. 17 retirement celebration in honor of Sheriff Shain Stephens from 2 p.m. to 4 p.m. at the old courthouse meeting room.

"Thank you, Shain, for [your] reported 41 intakes, 17 adoptions, 11 years of service to Harrison County and the Sheriff's Department," stated Judge Marshall.

-The Judge also noted the Dec. 10 groundbreaking for the new Cynthiana-Harrison County Fire Training Facility at Industrial Park on Sea Biscuit Way, at 2 p.m.

-The next Fiscal Court meeting will be Tuesday, Dec. 9, at the old courthouse starting at 5:30 p.m.
