## Criminal gets two more years for threatening prosecutor

MOREHEAD A Rowan County man already serving a 15-year sentence will spend two additional years in prison, Attorney General Russell Coleman announced Friday.

Michael Hall, 48, pleaded guilty to one count of intimidating a partici-

pant in the legal process, which is a Class D felony. He was sentenced to two years to run consecutively to his current stint. Hall was sentenced in May

2024 to 15 years for attempted murder, assault, strangulation and wanton endangerment This additional two-year sen-

tence is a result of pleading guilty to making threats against the Rowan County Commonwealth's Attorney. According to court documents, Hall was

recorded during a jail phone call in October 2023 threatening Commonwealth's Attorney Ashton McKenzie. At the time, McKenzie was prosecuting Hall for the aforementioned violent offenses. Court records show Hall admitted he made

the threats in an attempt to influence the outcome of his case.

"There will be zero tolerance for those attempting to tamper with justice and threaten our public servants who administer the rule of law," AG Coleman said.

Kentucky State Police investigated the case. Assistant Attorney General Barbara Maines Whaley prosecuted the case.

## Judge denies bond reduction for veteran with multiple DUIs

**CATLETTSBURG** A Boyd County circuit court judge denied a bond reduction for a military veteran who has been charged with operating a vehicle under the influence four times since the beginning of 2024.

David P. Ferguson, 46, of Ashland, is in the Boyd County Detention Center on a \$50,000 bond after being arrested in early July.

He was indicted on charges of fourth-or-greater-offense operating a vehicle under the influence of substances, driving on a DUI-suspended license, failure to surrender/revoked operator's license and expired registration.

Ferguson appeared in court Friday via videoconference from the jail in front of Judge George While the defense argued to

lower bond based on no criminal history prior to "this brief period" of similar arrests, Assistant Commonwealth's Attorney Gary Conn said he's concerned for the public if Ferguson is released from iail.

Both Conn and Davis voiced

their appreciation to Ferguson for service to his country, but the judge ultimately agreed with Conn that it would be dangerous to increase the chances of his release by lowering the bond.

The defense said Ferguson "desperately needs and wants help." Judge Davis said that should've

sought help after the first DUI, or at the latest, the second DUI. All of the DUIs, Conn said, resulted in single-car accidents.

The latest one — earlier this summer — occurred near Rose Hill Baptist Church where Winslow Road and Roberts Drive intersect.

KSP Trooper John Holbrook testified in court Friday. When Holbrook arrived, he said, he saw Ferguson leaning against the back side of his truck. A bystander believed Ferguson was under the influence.

Holbrook believed the same, he said, after observing constricted pupils, difficulty maintaining balance and slow or slurred speech. Holbrook said Ferguson failed sobriety tests.

Holbrook said Ferguson was cooperative throughout the process, but he did refuse a blood test.

'Each time he's been arrested. he's been involved in a single-car accident," Conn said. "... It gives me pause to let him out on bond because he's going to be driving and impaired, and maybe next time it won't be a single-car acci-

Davis shared the same fear.

"Being a veteran does not give you a get-out-of-jail card for free," Davis said.

The judge said while, yes, Ferguson has been cooperative and made court appearances, the second factor of bond is protecting the public.

'This is an individual completely out of control," Davis said. Davis said there's a "significant chance" Ferguson will repeat the pattern and the circumstances could be much more devastating.

"The bond remains as set," Davis said.

The judge said court-ordered treatment could be in the future for Ferguson, but that was not the purpose of Friday's hearing.

Ferguson's next pretrial conference is set for Friday, Oct. 17.
