Was a model citizen. Never bothered anybody, just contributed his knowledge and some time and resources to help the local FFA and farm groups here and there, as time drifted

"Boy, ' he said as we gained our composure, Walking on any part of Iwo Jima and not getting hit, well Hell ... everybody got hit. Everyone but me. And I swear it made me feel like I was walking in a raging thunderstorm and not a drop hitting me.'

But I guess he took some pretty good licks as it turned out.

I can't help but wonder what Edward would think of the pitiful way our parks officials are crapping on the Constitution and continue to violate federal law. I don't think he would like what his and his buddies sacrifices amounted too .... The sad saga continues.
