Upon arrival, Chief Deputy Conn quickly determined that the man was experiencing a mental health crisis. Despite the immediate danger and the risk to his own safety, Chief Deputy Conn took control of the situation with remarkable composure. Exercising patience, restraint, and compassion, he successfully de-escalated the crisis, ultimately convincing the gentleman to surrender peace-

The Burley Tobacco Referendum for the 1965, 1966 and 1967 crops iscompleted. Throughout the State of Kentucky about 99/5 percent of the voters were in favor of continuing the present program of controls and price support. Local farmers turned out in a record large number it is believed. The results in Fleming County showed 2943 ballots cast out if an estimated 3500 eligible voters. This is a turnout of about 84 percent. There were 2907 votes, 27 votes, and 9 that were declared ineligible. This shows a vote of about 99.1 percent in favor of the program. The county ASC Committee is very appreciative of all who worked toward getting voters out. Many different groups worked hard to help get voters interested and out to the

Plane Downed at Hill-

A four passenger, single engine plane, a Cessna 172, was forced down near Hillsboro when its engine ceased to function at approximately 2pm Saturday. The two pilots, Tom Willis of Ironton, Ohio and J.L. Garthee of Greenup, Kentucky were scared but unhurt. The first person on the scene to assist the victims were Jewell Call and Mr. and Mrs. Dean Manning, their sons, Barry, 9 and Trov. 7. The two men. one of whom had 100 miles of flying experience and the other 4,000 miles, made an emergency landing near E.R. Stephens' Hillsboro farm and close to the Robert Saunders residence. The pilots had taken off from Mt. Sterling and were enroute to an airport at Russell, Kentucky, near Greenup and across the river from Ironton. They became frightened when the plane's engine began knocking, but managed

a crash landing without

suffering any greater harm than being considerably "shaken up."
