WEST ISSUES STATEMENT ON VETO OVERRIDE OF SENATE BILL 65

Sen. Steve West, R-Paris, released the following statement after the Kentucky General Assembly voted to override the Governor's veto of Senate Bill 65, legislation that nullifies two Medicaidrelated administrative regulations previously found deficient during the 2024 Interim and 2025 Regular Session:

"By overriding the Governor's veto of Senate Bill 65, the General Assembly has reaffirmed its constitutional role as the policymaking body and protected the integrity of Kentucky's regulatory process. This legislation ensures that deficient administrative regulations-determined through a fair and transparent review process-cannot remain in effect simply because the executive branch disagrees with legislative findings.

"SB 65 does not create new policy, it enforces existing law by invalidating regulations that failed to meet statutory standards. The bill includes an emergency clause to avoid disruptions in Medicaid services, making it effective immediately.

"I'm grateful to my colleagues for standing firm in defense of legislative oversight and ensuring consistency for Kentucky families and Medicaid recipients."

SB 65 nullifies two Medicaid-related regulations, reasserting legislative authority and preventing disruptions in Medicaid services.

Sharpsburg man finds second valuable baseball signature

A Sharpsburg man hit a double last week after finding another valuable baseball player's signature inside an antique book.

We reported last week that Christopher Kidney stumbled upon the signature of early baseball legend Honus Wagner inside a 1948 copy of The History of the Pittsburg Pirates while browsing books at the Morehead Goodwill Store back in January.

Kidney's luck held up this past week when he said he was once again thrift shopping in Rowan County and bought a pile of 400 books for \$100 at a vard sale. One of the books turned out to be "The Quality of Courage," by baseball great Mickey Mantle and Roger Creamer, published in 1964.

Mantle is considered one of the greatest allaround baseball players in Major League Baseball history. He played for the New York Yankees his entire career, 1951 to 1968, and he was an All-Star for 16 seasons and was a 7-timeWorld Series Champions. He was a switch-hitter and considered one of the greatest offensive threats in

professional baseball history.

Kidney looked inside the cover the Mantle's book and saw Mantle's signature inside the front cover. He once again had the signature authenticated, with a response that it was "likely to pass authentication." Kidnev once again thanked his wife, Ashely, and family for supporting him and his friend, Brad Hanneken, for getting him started in the business.

Kidney's story has been picked up locally by Lexington TV stations, and he said he will be featured on CNN in a month or so.


