

Burns saw Wolfenbarger on a moped, and when he checked, noted Wolfenbarger was driving without a valid operator's license.


Wolfenbarger also allegedly had 3.5 grams of meth in his front pocket, according to the arrest citation.

Wolfenbarger was charged with improper equipment, driving on a DUI suspended license and trafficking in a controlled substance, 1st degree-meth.

Wolfenbarger and his attorney, Public defender, Chris Kippley, recently entered guilty pleas to the charge andf a second drug trafficking charge and in a plea negotiation, Wolfenbarger signed documents in which he agrees to serve nine years in prison with the Commonwealth Attorney opposing probation.

Fleming County sheriff, Tim Smith said help is available even for those with a history of abuse.

"Illegal drugs continue to have a deadly and devastating effect on our community. Fleming County Sheriff, Tim Smith said following the arrest. "They destroy lives, tear families apart, and fuel violence. If you are selling drugs in Fleming County, you better be prepared to face the consequences.
