## 125 YEARS AGO JULY 19, 1900

• Mrs. M.L. Anderson began her school at Hickman, Monday. Miss Eliza Smith will teach at Mason school house. Miss Katherine Moore will open school at Rice Academy, July 23rd.

• A druggist told us that it would be surprising to the people to know the number of people addicted to the cocaine habit here in Lancaster. The Council has stopped its sale in Stanford and many people come here now to get their supply.

• On last Sunday, the relatives and descendants of "Aunt Celia" Conn, assembled at her home, near Old Paint Lick, to help celebrate her eighty-ninth birthday. Children, grand children and great-grandchildren came from miles around, and together with others, brought well-filled baskets from which a bountiful dinner was spread, nearly a hundred partaking at different tables.

• About one o'clock Monday afternoon the kitchen at Dr. T.J. Hood's was discovered to be on fire. An alarm was given and people ran to the scene to do what they could in saving the building. The flames were leaping as high as the chimney when help arrived. A ladder was secured and a line of buckets quickly passed to Haselden's cistern, next year. By hard fighting the flames were subdued. The old squirt gun was dragged from the "engine" house and many exerted their strength in pulling it to the scene. The damage will amount to probable \$100.

• The Lowell school has the first library in the county. It was gotten up through the efforts of Miss Amanda Anderson, who worked unceasingly to secure it. There are sixteen volumes standard work, and there is promise of many more.

## 120 YEARS AGO JULY 21, 1905

• There were two wrecks on the Rowland branch Monday, the morning passenger train jumping the track at Gilberts Creek and the mixed train leaving the rail near Paint Lick. No damage was done but each train was delayed six to eight hours.

• Mr. and Mrs. William Lackey, of McCreary, are rejoicing over the arrival of a pretty girl baby, christened, Elsie Burnside.

• A meeting of all those interested in the project of building the new hotel will be held in the Police Court Room, Tuesday night, at 8 o'clock. • A large tobacco barn on the Wm. Day farm, near Well's store,

was struck by lightning a few nights ago, and was burned, along with 189 bales of new hay, just stored, several sets of harness, 50 chickens. About a half acre of growing tobacco near the barn was destroyed by the heat from the burning bar. Mr. Day carried some insurance on the barn but none on the contents.

• After a meeting of the Garrard County Fiscal Court on Monday evening, refund checks for insurance tax premiums are nearly ready to go out the door. The program should be closed as of September 30 but checks are expected to be in mailboxes well before that date.

In total, there were 2,127 applicants, comprising 3,027 refund checks to be sent out, averaging \$97.60 each, though most will be significantly lower and some higher.

When the program first began there was an estimated \$870,000 in the account which held the surplus insurance premium tax money. After the hospital debt was paid, the tax couldn't be removed until the next fiscal year, which created the surplus. At that time, the fiscal court decided to try and return the money due to a promise of a former fiscal court to only use those dollars from that tax to pay of the hospital.

The total amount refunded is now estimated to come in at \$295,436.48. That leaves a significant surplus still in the fund, even after paying for software and accountants.
