# Remembering the catastrophic Dry Ridge fire

n Feb. 25, 1927, a disastrous fire took place that wiped out the historic business district of the City of Dry Ridge. Included in the buildings that were destroyed was the world famous Carlsbad Inn and Spa, the Farmers Bank of Equity, the city post office, theater building, a doctor's office, many stores and several residences, all located on U.S. 25, just north of the intersection of Main Street and Broadway.

According to the "History of Grant County, Kentucky,' published by the Grant County Historical Society, the fire started in the Sanders-McAtee building, where it quickly spread across the street and set to flames the Carlsbad Hotel.


From there, a strong wind pushed the flames north, setting fire to the Farmers Bank of Equity, Dr. Renaker's Office, Clement's Restaurant, the post office and Bowman's Movie House.

After the fire, word of its damage made many newspapers across the region and on one of its headlines we learn of an interesting story: A local dog, a barking Irish Setter, alerted the residents of the Carlsbad Hotel that there was a fire, ultimately saving many

Though the fire caused lingering issues, including resignations from the Trustees of the City, the residents were quick to rebuild.
