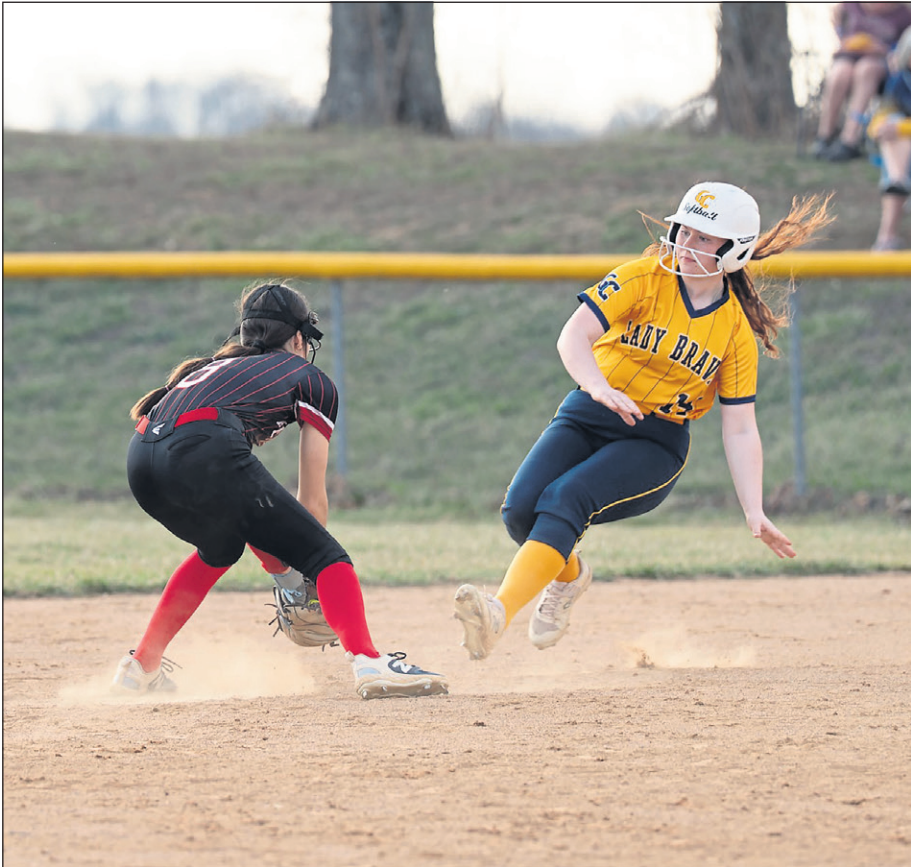

AN ORDINANCE OF THE CITY OF WILLIAMSTOWN IN GRANT COUNTY, KENTUCKY, AMENDING ITS' BUDGET FOR THE CITY OF WILLIAMSTOWN PURSUANT TO K.R.S. 91A.030(10) FOR THE FISCAL YEAR BEGINNING ON JULY 1, 2024, AND ENDING JUNE 30, 2025 AND PROVIDING THAT NO MONIES SHALL BE EXPENDED BY OR ON BEHALF OF THE CITY OF WILLIAMSTOWN EXCEPT IN ACCORDANCE THEREWITH
