Thorne honored as distinguished veteran in Frankfort

Retired U.S. Marine Corps Sgt. Maj. Jimmy Thorne was honored with a legislative citation from the General Assembly of the Commonwealth of Kentucky on Aug. 27, during the meeting of the Interim Joint Committee on Veterans, Military Affairs & Public Protection at the Capitol Annex in Frankfort. Thirty senators and representatives were in attendance at the meeting as well as several audience members.

Thorne showed up wearing his old Marine Corps uniform, which still fit him like a glove. His black shoes gleamed with a regulation military shine.

He was nominated for the honor

by Sen. Matt Nunn and Rep. Savannah Maddox. Before the meeting, he chatted with them and a few other dignitaries.

During his recognition, Thorne was seated at the table between Nunn and Maddox.

When asked to identify himself for the record, he chirped, "Jim Thorne! Good morning, Kentucky!" and got a hearty chuckle.

"I can think of no person more deserving of this recognition than Sgt. Maj. Thorne," Nunn said.

"When they were working on it [the citation] they sent me the final draft; they said 'Well, the font is as small as we can get it, so if you want to add anything else you have to take

"Know ye that Sergeant Major Jimmy Thorne (USMC, Ret.) is recognized and honored for his years of exemplary service as a distinguished American veteran and respected member of his community. An honorable veteran of the United States Marine Corps who retired after more than three decades of brave service to his country, including during the Vietnam War, Sgt. Maj.

STREAMLINING THE ZONING CHANGE PROCESS

The Commission has periodically been asked to streamline the zoning change application process. To date, the process is:

Application received

· Commission schedules public hearing

· Before the hearing, at the meeting, Commission decides to or not remit to a Subcommittee

· If remitted to Subcommittee, then committee meets and will meet with applicants.

· Commission schedules another hearing

· Committee reports to the commission any conditions or changes for the application

· The public and applicant/s can address the Commission

· Once finished, recommendations based on the hearing and subcommittee results will be sent to the appropriate legislative body

This process can take upwards of four months.
