Suspended Little Leaguer's bat sells for nearly \$10K at auction

PHILADELPHIA — The bat tossed in the air by a New Jersey Little Leaguer to celebrate a home run that earned him a suspension later lifted by a judge sold Friday for nearly \$10,000 at auction.

All proceeds from the sale of 12-year-old Marco Rocco's signed bat will be donated to the program he plays for, Haddonfield Little League.

"Marco loves Little League and is happy that he is able to give back to an organization that he is very fond of," his father, Joe Rocco, said in a text. "Little League was such a big part of Marco's life for a long time."

Auctions drew 68 bids. sided with the boy.

The winning bid was \$9,882; the name of the winning bidder was not announced.


Marco's bat flip on July 16 in the final of the Little League sectional tournament resulted in an ejection, a one-game suspension and a legal fight.

The suspension would have kept him out of the first game of the state tournament. But Joe Rocco took Little League to court and won an emergency temporary restraining order that allowed Marco to play in the double-elimination tournament.

The incident was also commemorated with a pin available at the Little League World Series.

CITY OF CRITTENDEN ORDINANCE NO. 345-2025

AN ORDINANCE PROVIDING FOR AND MAKING THE REAL PROPERTY, PERSONAL PROPERTY, MOTOR VEHICLE AND WATERCRAFT TAX LEVY FOR CITY PURPOSES FOR THE FISCAL YEAR BEGINNING JULY 1, 2025,

WHEREAS, the City Council for the City of Crittenden, Kentucky, is required by KRS 92.280 to enact by ordinance each year, a tax levy on all real property, personal property, motor vehicles and watercraft;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF CRITTENDEN, KENTUCKY, AS FOLLOWS:

SECTION ONE

That the following tax levy is hereby made for City purposes for the City of Crittenden, Kentucky, for the fiscal year beginning July 1, 2025, and ending June 30, 2026, inclusive, to wit:

There is hereby made a tax levy of point one seven four (\$0.174) on each one hundred dollars (\$100.00) of assessed real property subject to ad valorem tax by the City of Crittenden and point four six seven (\$0.467) on each one hundred dollars (\$100.00) of assessed personal property subject to ad valorem tax by the City of Crittenden of all personal property subject to ad valorem taxation by the City of Crittenden, the proceeds of which shall be designated to the General Fund for the general operation of City Government.

SECTION TWO

All matters relating to the payment of the taxes imposed on motor vehicles and watercraft hereunder shall be in accordance with KRS Chapter 134.800 et seq.

SECTION THREE

The taxes imposed hereby shall be due and payable before the 1st day of January 2026, at the Office of the City Clerk of the City of Crittenden, 117 South Main Street, Crittenden, Kentucky 41030, and shall be delinquent on January 1, 2026. If paid on or prior to November 15, 2025, there shall be a Two (2%) Percent discount. On and after January 1, 2026, there shall be added thereto an interest penalty of Ten (10%) per annum from January 1, 2026, until paid, plus the cost of collection including court costs and attorney's fees.

SECTION FOUR

If any section, subsection, sentence, clause or phrase of this ordinance is held unconstitutional or otherwise invalid, such infirmity shall not affect the validity of the remaining portions of this ordinance.

SECTION FIVE

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION SIX

This ordinance shall take effect after its passage and publication
