

Meet the Candidates

Senate Contenders Visit Hart County

The Hart County Republican Committee met on August 4 at Melissa's on Main.

Guest speakers for the evening were U.S. Senate Candidates Daniel Cameron and Jacob Trimble, as well as State Representative Ryan Bivens.

Daniel Cameron
Daniel Cameron addressed those in attendance first. Cameron, who served as Attorney General of Kentucky from 2020 until 2024. He now is a Republican candidate for U.S. Senate.

Cameron spoke of his family and how entering the race can help ensure that all children, his sons included, can grow up in a world based on merit and opportunity.

"We want them to grow up in a community with values based on merit and opportunity as opposed to handouts and division and the weaponization of terms, like DEI," said Cameron. "I often tell people we don't need more diversity, equity, and inclusion. We need more merit, excellence, intelligence, and integrity."

He also spoke of the economy and industry.

"Kentucky has a unique opportunity to lead," he added. "A lot of industries are going to need one big thing... what we have here in Kentucky is coal and natural gas, and those are reliable and low cost."

Cameron explained he'd love to see businesses move to Kentucky due to the rich resources, and he continues to fight for the empowerment of coal and natural gases, while he also fights for farm communities and law enforcement.

Regarding education, he explained he felt the Department of Education should empower the states, and in terms of homeschooling, he supports parents having the autonomy to teach their own children through a curriculum of their choice.

He praised President Trump for lower

border crossings, and promised to support a secure border and be an advocate for security and strength.

"The last thing I'll say to you is that as I think about this race and our family and what we want to represent, it's really to be the hands and feet of Christ and to be salt and light in this world," said Cameron. "We stand proudly in our faith and our relationship with Christ, and we won't always do that perfectly...but at the end of the day, I know that as Kentuckians what we care about is helping our neighbors and being committed to the values of scripture, so that's what I want to take to Washington D.C. as well, and will stand on that, because I think that is just as important as the issues that we will confront in the United States Senate."

Jacob Tremble
U.S. Senate Candidate Jacob Tremble introduced himself as a 30-year-old Navy veteran from Somerset, who also has experience in the health field.

"I never came from money or politics," said Tremble. "My father worked as an engineer at Toyota for years...He's came out of retirement to help his little community rebuild, and he's really brought back industry to that community... That's what gave me the basis on what to run on. The little people need a voice, and they don't always get it."

He explained he is passionate about big companies controlling little people while the middle class is destroyed.

"There's only one thing you do, you can elect someone who will fight back," said Tremble.

He spoke on the importance of term limits and addressed his concerns of debt and inflation, as well as the success thus far of tariffs.

He also stressed the importance of factories and engineering and energy, and also small businesses.

"We have to support the small businesses," he said. "Owning something and saying 'this is my asset and I want to expand it' without the federal red tape."

Regarding education, Trimble favors decentralizing funding for education, and not only give it back to the state, but also to the people.

Ryan Bivens
State Representative Ryan Bivens first spoke on election integrity and complimented local offices in the area he serves.

"Nobody's system is perfect, but we have integrity here," he said.

He spoke of the growth of the Republican Party and shared his views on the reasoning.

"We've had a change in dynamic in the state," said Bivens. "You've seen a change right here in Hart County, and I think it's because we've got a party who has left the people. It's left it's members. That's why the Republican Party has picked up so many people...We don't need to see the same thing happen to us. The Democrats have done this to themselves."

Bivens then answered questions regarding The Department of

Education, which he claimed had good parts, but also parts which needed to go away.

He also addressed issues with social security, especially at a federal level, and concerns with younger generations who will need to step up into the workforce in a time
