No Change in Real Property Tax Rate

The City Council of Horse Cave met in regular session on Monday, September 8th. Council members Velpha Hatchett, John Buckingham, Vickie Rogers, Mandy Hatcher, and Allen Poynter were in attendance, as well as Mayor Randall Curry.

The council opened the meeting with a presentation of possible tax rates, by City Clerk Joy Bennett, followed by a discussion and decision, with the first reading of the established rate.

The recommended Compensating Rate was .123%, which would have been a slight increase from the .118% last year. In terms of revenue, Bennett announced that keeping the same .118% rate would bring in \$35,000 less than last year.

"We had a larger assessment this year, and then we had a little over a million dollars in new growth," explained Joy Bennett. "Using the .123%, it will bring in \$31,000 more this year than last year... what we're doing is we're trying each year to have the same rate to keep it at the same level."

Mayor Curry recommended the Council take the compensating rate, as recommended by the Department of Local Government, stating that it helps with grant approvals, but ultimately left discussion and decisions up to the Council.

"I don't want to raise taxes, and I wish they wouldn't give us a choice," said Vickie Rogers. "Raising taxes even a little bit to get the compensating rate, I don't like that. We have a lot of people with fixed incomes and I don't know how much that will affect them."

It was explained that for a property valued at \$100,000, the difference would be about \$5-\$6 more.

Another figure anticipated that if the council chose the compensating rate, it would come with an increase of \$92.11 per person, per year.

"We really don't need to lose revenue," said Bennett. "If we go with .118%, we're going to lose revenue... Our (rate) is really, really low."

Vickie Rogers expressed that she appreciated that the city had always set a low tax rate.

"We just raised property taxes last year, so why hit them again," echoed John Buckingham.

Curry explained that the budget could absorb the loss, explaining "Joy and I are very conservative with the city's money, just like it's our money.... If you don't want to raise it, we can live with it."

Mandy Hatcher echoed the opinions of Rogers and Buckingham, especially in light of the new property assessment.

Buckingham made a motion to not set it as the compensating

rate, but instead leave it as is, at .118% real property and the compensating rate on personal property at .1837%. Rogers seconded. The motion unanimously passed among the five members present.

Department Reports

Fire Chief Mason Michael presented the Fire Department Report, which included 34 medical assists, 4 alarms, 6 fires, 5 injury accidents, and 6 agency assists, for a total of 55 runs.

Buckingham asked how many active members were on the department.

Michael explained there are 27 fire department members on the roster, with an average of 6 responders per emergency, stating "We're very fortunate with our members and their dedication. We had a structure fire the other night and had 14 members show up."

"I commend you on the job you're doing," said Buckingham to Michael. "That's why you're getting firefighters to show up. It's because of you."

In the Public Works Report, Randy Russell presented on 3 grave openings, limb and leaf pick up, mowing, and Russell stated that all but one sign is left for completion of the Sunset Dome Park.

Concerns

There were no citizen concerns.

During Council Concerns, Mandy Hatcher questioned a 2017 ordinance regarding a citywide curfew for youth. She explained the ordinance currently reads that the hours are 11 pm to 5 am, Monday through Friday and weekends midnight to 5 am.

"There's been quite a few young teenagers running around all over the city," she explained. "They're hiding in businesses. They're playing hide and go seek at all hours of the night. 11:00 is pretty late on a school night."

Hatcher also relayed a recent occurrence where Airbnb guests were staying inside the city limits and came out to find youth hiding from friends in their vehicle.

"It's good to bring up," said Rogers, mentioning a recent incident in Texas where a youth was fatally shot while playing a doorbell ditch prank. "They need to be in bed."
