Sunday, Secretary of State Marc Rubio was asked on NBC's Meet the Press whether citizens and non-citizens in the U.S. are entitled to due process and he said "Yes, of course". Secretary Rubio also was peddling stories on why three small children, all of who are US citizens were deported with their mothers, one of those little kids has cancer and was snatched up by immigration officers and booted out the country.

His wife did at one-time seek a restraining order against him, but they reconciled.

The court battle over how to enforce immigration is stealing the spotlight from some of the other terrible decisions that have been made by the Trump Administration. One of those issues is Doge cutting the staff of the Social Security Administration by 13 percent. The immediate effects of cutting that many jobs is a slowdown in how fast the organization can process claims from retir-

The side effects of tariffs are just now coming into focus. But manufacturers have been quoted by NBC saying the tariffs are already taking effect, particularly tariffs on replacement parts for manufacturing equipment. China has also limited the export of rare earth minerals to the US. Those minerals are used in electronic equipment.

We need campaign finance reform now!

In a recent story posted on the Kentucky Lantern's website the wildly successful fund raising of Rep. Andy Barr and the not so successful efforts of former Kentucky Attorney General Daniel Cameron were detailed. Both Barr and Cameron are lining up to run in the Republican primary for the seat that Sen. Mitch McConnell is vacating.

In a recently filed federally required report on contributions Barr had received \$733,000 in contributions from Political Action Committees (PAC) and Cameron just \$1,000. Barr is awash in cash according to the Kentucky Lantern he rolled over \$3.7 million from his house campaign committee to his senate campaign. Barr was reported having \$5.3 million on hand in his senate war chest at the beginning of this month. Cameron had \$455,000 at the beginning of the month.

According to the Kentucky Lantern Barr's most recent contributions from PACs were from banks.

Our country has needed campaign finance reform for decades. When it takes millions upon millions of dollars to run for office who do we think is going to get the most attention from elected officials? In our view it will be those who show up with millions of dollars.

It is also our view that much of the discontent in our country today has its roots in the constant flow of negative advertising that comes in every election cycle. It is little wonder that people have such a negative and fractured view of others who may not share their exact same view or have different back grounds. All too often the focus of campaign advertising is to find someone to blame and then create a problem they are responsible

We need campaign finance reform and a total overhaul of how political campaigns work. Candidates and the PACs must be held accountable for what they say, lengths of campaigns must be shortened and the amount of money spent on campaigns limited. We need campaign finance reform now and campaign reform across the board.

Love in that story so tender, clearer than ever I see; stay, let me weep while you whisper, "Love
