The weather caused landslides, numerous impassable roads and school closings. It took more than two weeks for all floodwaters to recede and be moved by pumps into streams throughout the county.

Hodgenville approves Restaurant Tax The Hodgenville City unanimously Council approved to implement a 3% tax to the bill of any fixed or mobile commercial establishment that prepares and serves ready-to-eat foods sold within the city limits. Revenue garnered from the tax is disbursed to the Hodgenville Tourism & Convention Commission and must be utilized for projects and undertakings that promote and develop recreational, convention and tourist activity within the city.

DUI driver enters guilty plea
