## County to purchase new garbage truck

The Marion County Fiscal Court voted last Thursday to purchase a new garbage truck. Last month a company from Nashville, TN, brought a truck to the fiscal court meeting for magistrates to view and provided a quote for that truck. However, the court decided to purchase a truck from Municipal Equipment in Cincinnati, OH. ### C'ville program brings horses, special needs children together

ammy Garrison remembers the night as if it happened yesterday. It was over 20 years ago when he and his wife Marchetta were returning to Campbellsville after making one of their many trips home from Shelbyville where they had taken their daughter for a therapeutic horse-riding session.

"She asked me if I thought we could do something like this in Campbellsville," Garrison said. "I looked at her and asked if she was crazy. After I said that, I tell you it was a long 45-minute ride home."

Marchetta was not as crazy as her husband imagined.

Their REATH (Riding Enhanced Around Therapeutic Horses) Center is celebrating its 20th Anniversary this year and is holding an Open House Saturday to show off its horses and give various demonstrations.

Over the years, they have been a resource for hundreds of people with special needs who needed help with motor skills, balance and social skills. Being around a horse also improves their confidence and speech and language skills.

"There is a connection between a horse and a person," Marchetta said. "A horse can hear your heart beat from six feet away and his heartbeat will mimic the person. If you are anxious and nervous, the horse will react the same

The Garrisons took an interest in such a program when they read a story in Kentucky Living Magazine about the one in Shelbyville. Their daughter Sabrina was born prematurely and doctors discovered she had Cerebral Palsy a week later.

"Her left side is weaker than the right and she has very little use of her left hand, Sabrina's father said.

#### Man indicted on possession of matter involving sexual performance by minor

possessing or viewing matter portraying a sexual performance by a minor under 12 years of age was one of the individuals indicted by the March Marion County Grand Jury.

Thomas Goodin, 61, of 509 Cypress St., Lebanon, was indicted for

possession/viewing of matter portraying sexual per- 12 or under vulnerable victim years of age, a Class C felony. The grand jury charged that these events happened on or about Nov. 1, 2024, when Goodin knew its content and character, and that the sexual performance is a minor under 12, knowingly had in his possession or control any matter which visually depicts and actual sexual performance by a minor person under 12, or intentionally viewed any matter which visually depicts an actual sexual performance by a minor person under 12.

The bond was set at \$50,000.00 full cash with no violations of

the law, and no use of drugs or alcohol. Goodin was arrested on Oct. 3, 2024, and charged with

first-degree rape, victim under 12 years of age, first-degree sodomy, victim under 12 years of age, and first-degree sexual abuse, victim under 12 years of age.

formance by a minor under 12 (Class B felony). The grand jury charged that these events happened on or about Aug. 24, 2024, when Peake intentionally abused a person, or permitted a person of whom one has actual custody to be abused and caused serious physical injury or placed a person in a situation that may cause serious physical injury, or caused torture, cruel confinement, or cruel punishment to a person 12 years of age or less, or who is physically helpless or mentally helpless or aided, abetted, or counseled in said act.
