Kentucky ranks in the top 10 in states with the highest job opening rates

Currently, the national jobopening rate is 4.4%, which equals about 7.4 million available positions.

In Kentucky, that number is 4.8%, tying it with three other states at No. 8 in states with the highest job opening rates, according to a new study released by Podium AI, a customer AI service platform that analyzed the latest data from the Bureau of Labor Statistics. Kentucky's rate is 9% higher than the national average.

"What really stands out is the contrast between smaller

states like West Virginia and Maine, which are posting the highest rates, and much larger economies like California and Texas, which sit near the bottom," said Eric Rea, CEO

and founder of Podium AI. "It's 5.6%. not that California and Texas don't have jobs – they have hundreds of thousands – but because their workforces are so large, those openings represent a much smaller share overall. It's a reminder that job seekers in a smaller state may actually find more opportunities, proportionally, than in some of the biggest states."

The state with the highest rate of job openings is West Virginia at 6%. The state has 46,000, and its job-opening rate is 36% above the national average. Three states are tied for No. 2 (Maine, North Carolina, and South Carolina) at

Kentucky is tied with Maryland and Wyoming at 4.8%. The Bluegrass State has 105,000 job openings, while Maryland has 142,000 and Wyoming,

"High job opening rates often reflect strong demand for workers, but they can also point to challenges for employers in filling roles," Rea said. "States like West Virginia and Maine may be experiencing tight labor markets, where businesses are competing harder to attract staff. That can create opportunities for job seekers, but it also puts pressure on employers to improve pay, benefits, and

workplace flexibility."

The state with the lowest jobopening rate is Washington at 3.7% with 142,000 job openings 16% below the national average. Next comes Hawaii and California tied for second (3.8%), and Texas, South Dakota, Pennsylvania, and Indiana tied for third (3.9%).

The study notes that California and Texas both appear near the bottom of the rankings despite their huge number of vacancies. California had the most job openings in the country at 702,000, while Texas had 575,000. The reason, the study noted, comes down to population size—with such large

workforces, even hundreds of thousands of vacancies only make up a small share of total

"These numbers highlight the importance of looking at both absolute job counts and the rate of openings," Rea said. "A state like New York or California may have the highest number of openings, but competition will still be fierce because of the size of the workforce. In smaller states with high rates, workers may find they have more leverage and choice."

Kentucky in top 20 states for biggest mortgage declines

Anyone in the market to buy a home knows how difficult it has become, thanks to a combination of high prices and a national housing shortage.

But there could be a light at the end of the tunnel, as the average mortgage interest rate decreased in all states between the first two quarters of 2025.

"It's a difficult time to buy a house, given that home prices have risen astronomically over the past few years and housing shortages make it hard to find the right place even if you have the money," said Chip Lupo, WalletHub analyst. "The

upside is that consumers' homebuying struggles are alleviated by the fact that the average mortgage interest rate decreased in all states between Q1 2025 and Q2 2025. Although interest rates are still down a bit from the highs we saw two years ago, they're a far cry from the historic lows during the

The personal finance company has released its report on states where mortgage interest rates are decreasing the most, with Kentucky coming in at No. 14. Mortgage rates decreased by 14.07%, with the average rate in Q2 at 5.11%.

"Alabama had the largest

decrease in the average mortgage interest rate between Q1 2025 and Q2 2025, at around 16.7%," Lupo said. "With this significant decrease, the average mortgage interest rate in Alabama dropped to only 4.8% in Q2 2025, making it the 10thcheapest state."
