November 2025 County Judge Executive Monthly Report

I am thankful for the grants Lewis County has been awarded, the honor of earning our Recovery Ready Community certification, and the day-to-day progress we are making. I attended the Buffalo Trace Housing Corporation Board of Directors meeting. Judge Tina Teegarden called the meeting to order. The past meeting minutes were approved. Steven Culp presented and explained the financial report. Emergency repairs for the Fisher House were discussed. The meeting was then adjourned.

Next up was the Camp Dix Fire Department progress meeting. Things are coming along very well with the Fire Department/Community Center. Big progress has been made on plumbing and concrete. We viewed the progress and discussed a few small change orders. The outside is now completed and we are looking forward to the next progress meeting in a couple of weeks.

I attended the Lewis County Ambulance District Board of Directors monthly meeting held at Lewis County EMS on Clarksburg Rd. Chairman Danny Palmer called the meeting to order and presented the meeting minutes. Treasurer Brenda Cunningham presented the financial report. Both were approved. Director Michael Byble presented his monthly activity report and updated the board on several things. The service is now approved as an Advanced Life Support (ALS) service. A big thank you to Michael, his EMS crews, and the Board of Directors for their determination and perseverance in continuing to move the ambulance service forward. Treasurer Brenda Cunningham was presented with her commission as a Kentucky Colonel for her work with Lewis County EMS. Thank you, Brenda!

We hosted the Buffalo Trace Lewis County Water Sewer projects ranking at the Lewis County Courthouse. These meetings are held in each of the BTADD counties. Then, a regional meeting is held at BTADD where all the projects are put together and ranked. The regional ranking will take place at BTADD in December.

Met with BTADD's Kristie Dodge along with Executive Vice President Richard Taylor and Scott Surber, both from The Center for Rural Development. We discussed the ARC grant Lewis County received in 2022 for \$800,000 to expand broadband in Lewis County. There are many guidelines that must be followed in using the funds. We have tried a few different options that have not worked, so we are looking at another potential route that we hope will be successful. Richard and Scott shared their thoughts and gave examples about how other counties have been successful using the funds. We also discussed partnering with internet service providers (ISPs) and using the funds to help the ISPs extend to hard-to-reach areas.

I signed up to run for another term as Lewis County Judge Executive. It has been an honor to serve these past two years and 11 months. I am excited about continuing to work together and move towards the bright future I am confident Lewis County has. I would be honored to have your support and your vote in May of 2026.

I presided over the November Fiscal Court Meeting. The meeting was opened with prayer by Pastor Kent Moore of Cornerstone Church in Tollesboro, followed by the Pledge of Allegiance led by Sheriff Defense Grant Program Coordinator along with CWDG Specialist Jeff Wagers, Leigh Nedlo,

and BTADD's Kristie Dodge attended to present the CWDG check to the court. Danny Palmer was presented with a commission for Kentucky Colonel by the court and Governor Andy Beshear for his incredible leadership, partnership and teamwork in helping start the Lewis County Ambulance Service. Thank you, Danny! The court approved the advertisement for the 80/20 bridge work project at Wildwood Trails. The court discussed a partial closure of Red Brush Hill Road in Garrison. The court approved Resolution #25-17: KYEM Statewide Mutual Aid Agreement. Joe LeMaster was reappointed to the LC Extension District Board, and David Reis was appointed to the Extension District Board. Both terms expire 12-31-2028. Waylon Salvia was approved to go from PT to FT and was given a pay increase after earning a class A CDL. Doug Kraft was hired

Auctions by Cooper will proudly be selling at absolute auction at the 1883 George Morgan Thomas home. Originally in 1883 George Morgan Thomas built the Victorian showplace for his family home. Mr. Thomas was a very prominent member of Kentucky society. Having a most impressive career that helped shape Kentucky to this day and leaving an impression that will not be soon forgotten in his hometown of Vanceburg. Just a brief list of some of the positions Mr. Thomas held, Solicitor of Internal Revenue appointed by President McKinley, appointed US Attorney by President Garfield, elected US congressman, elected Circuit Judge, elected twice and reelected twice to KY legislature, elected Lewis County Judge, elected Commonwealth's Attorney, elected school commissioner, and school teacher.

This I believe to be the premier example of Victorian homes in Vanceburg having many of the original features and outstanding modern improvements, The home has served as private residence, hotel and lastly the Visitors Center for the City of Vanceburg. The beautiful Victorian home features the original oak entry door with double frosted glass sidelights and leaded and beveled transom window, on 1st floor a large entry/greeting space w/orig. frosted transom window w/initials GMT and orig. gas light fixture (has been converted to electric), large music/courting room with pocket doors and one of the finest examples of a fireplace mantle w/rope twist columns, floral drape carvings and original beveled mirror, (the mantle was professionally refinished in the early 2000s), also in the music room a large piece of stick and ball fret work with a carved harp note in the center and rope twist columns from the floor to the fret work (columns match fireplace mantle). Large living/sitting room w/beautiful fireplace mantle. Pleasantly spacious formal dining room w/ linen closet and access to the roomy kitchen with newer cabinets, nice sized mudroom, large pantry/storage room access to the partial basement from mud room, where the recent furnace is located, the home does have central heat and air. The basement is a piece of architecture in itself with quarried and hewn stone walls and brick floor, 2 very large restrooms, hardwood floors throughout with tile in the restrooms, decorative hardwood staircase in the entry and servants staircase in the rear of the home. Upstairs features 6 bedrooms, 3 very large bedrooms and 3 small bedrooms, 3 with orig. fireplace mantles, south and east side widow's walk with 2 access doors, original ornamental iron rail, restroom with tile floor, small sitting area, and hardwood flooring throughout. The exterior showcases Victorian architectural design such as columns, cutouts, arches, fish scale and dimensional siding, cast iron widow's walk railing, porches and many more Victorian architectural designs. The house has porches on 3 sides with access to the home with a handicap poured ramp on the north side. The grounds have been professionally landscaped and very well-maintained poured sidewalks, on street parking in the front and private asphalt parking area in the rear. Updates include separate climate control on each floor with 2 split system heat pumps. The potential with a variety of options is limitless with this beautiful historic building. The lot is with an easement in the back, historical markers, and industrial flagpole stay, the home was completely restored in 2006; while keeping most of the original materials and replacing some with period correct materials (we have copied timeline pictures of the restoration).
