AN ORDINANCE LEVYING PROPERTY AND FRANCHISE TAXES FOR THE CITY OF LIVERMORE, KENTUCKY
ORDINANCE NO. 09-2025-01

The CITY COUNCIL of the City of Livermore, McLean County, Kentucky, does ordain as follows: That there be, and there is hereby, levied a tax for revenues for the general purpose of said City for the year of 2024 upon the following named property: **FRANCHISES, REAL AND PERSONAL PROPERTY.** On each one hundred dollars (\$100.00) of assessed value of taxable real property, including franchises, owned or located within the city limits, there is hereby levied a tax of fifteen and four-tenths cents (\$.154). On each one hundred dollars (\$100.00) of assessed value of taxable personal property, including franchises but excluding motor vehicles and motorboats, owned or located within the city limits, there is hereby levied a tax of thirty-two and twenty-five hundredths cents (\$.3225). The taxes of real and personal property herein levied for said City shall be due and payable on the 31st day of December, 2025. On all tax due and unpaid as of the 1st day of January, 2026 there shall be added a penalty of ten (10) percent. The franchise tax herein levied for said City shall be due and payable on the 31st day of December 2025, and shall be subject to a penalty of ten (10) percent on the tax due and unpaid after the 1st day of January, 2026. The duly appointed tax collector for said City shall have the same power to collect said taxes, together with penalties thereon, as sheriffs have to collect the county and state revenue, and may distrain for the collection of said taxes and penalties at any time after it is due and in the manner of sheriffs in collection of state revenue. This ORDINANCE is to be in full force and effect after its passage and publication according to law. First reading to record was at a regular meeting on the 14h day of August 2025. Motion for passage was made by Austin Babb, seconded by Stephanie Fulkerson at a regular meeting on the 11th day of September 2025, with 6 members present and 6 members voting for passage of this Ordinance.
