State alerting residents to new text scam

A new texting scam targeting Kentucky residents has been identified by state officials.

The text appears to offer \$250 to Kentucky residents who complete a survey, an alert from stopscams@ky.gov said. The sender does not identify themselves and the link is attempting to collect personal information from the recipient.

Officials advise residents to not click on the link or respond. Instead, they advise recipients to delete the text and report it as junk from your mobile device if you receive it.

In today's digital world, a survey pop-up or mes-sage claiming "complete this quick questionnaire and get paid!" might seem harmless or even appealing. When you're promised payment for answering a few questions, the survey may be doing more than just asking your opinion.

It could be:

 Collecting personally identifiable information name, date of birth, address, Social Security number, banking information — under the appearance of validating or sending your "reward."

- Getting you to click links that install malware or direct you to phishing web-
- Using your data for identity theft or spam marketing.

Because legitimate businesses don't typically pay large amounts for generic survey participation, the moment you see promises like "get paid \$50 just for answering 5 questions," consider it a serious red flag.

Other red flags to watch

- The survey claims to be from a well-known brand or chain, but the questions or rewards don't match what you know about that brand. For example: a grocery store asking about jewelry
- It's unclear who is running the survey and why. Real surveys will clearly state the brand, purpose and how the responses will be used.
- The survey contains typos, bad grammar, and incorrect or misused company logos. Scammers often copy branding which leads to errors.
- The survey link looks like it belongs to a brand, but when you hover or check, it actually leads somewhere else: different

domain name variations or odd URLs.

 The survey urges you to act quickly before you have time to think.

Officials advise that if an offer sounds too good to be true, it probably is. Don't click on links from unknown senders. Never give out personal information on a website you have never used before.
