# Cherished letters sent by WWI soldiers to Taylor County

The United States entered World War I on April 6, 1917, when Congress passed a declaration of war against Germany. President Woodrow Wilson had requested the declaration on April 2, citing Germany's unrestricted submarine warfare and its attempts to entice Mexico into an alliance against the U.S. By June 5, the draft began for men between the age of 21 and

WWI letters sent home provide us, but more importantly, their family, glimpses into a soldiers' life and emotions. Letters home – to loved ones – were generally a soldier's attempt to maintain normalcy in this new world that was anything but normal ... and to reassure their family that they were OK.

Families often shared these letters shared them with their readers.

As we continue to honor our veterans, specifically in conjunction with Veterans Day this Tuesday, Nov. 11, Taylor Regional Archive Center would like to share a few snippets of some of the letters in our files.

Somewhere in France, Aug. 7, 1918: Dear Moma and Papa. Heavy hangs the dawn of another night. The rays of the golden sun are just passing from view. Very soon, a weary soldier must pillow his head for another night's rest. All is well with me, except the heavy load of loneliness that seems to crush me down. When I sit all alone as I am now, my mind drifts back to the time when I stood at mother's knee. I was just a tot. I did not realize what it was to be separated from the best and only friends on earth.

Somewhere in France, September 1918: Dear Father, Received your and Lillie's letter this morning. Was glad to hear from home. How is mother and the rest? I wish I could tell you about things I have seen. I have seen a lot of things you are reading about and that is all I want to see. I'm ready to come home Gilbert F. was here to see me last now. ... The Americans took 13,000 night. He is in the same camp with prisoners yesterday. I can tell you

Somewhere in France, Oct. 1, 1918: Dear Wife, I arrived safely overseas and am in good health. Hope you and the baby are the same. It is a very pretty country over here and I have seen a great deal of it. I guess the baby is a great big fat thing by now. I would love to see him, but you can kiss him for me. Tell Eastin Sanders if he does not write me soon, I am going to shoot him with one of our cannons when I get home. Don't worry about me

me now. We will stay here four or a lot when I get back home. How for I am coming back, so be of good cheer and strong of heart and it will all come out well. News is scarce. I will tell you more when I get home. I remain your husband, Pvt. Jessie Marple (Son of William and Liza Marple)

Somewhere in France, Oct. 22, 1918: Dear Pearl, Your welcome letter was received today. I was so glad to hear from you. I got two letters from you this week, and you can bet I am pleased to get letters from you. I am close to a town and learned to talk French very well. I haven't seen any pretty French girls yet. Some people may think French girls are pretty, but I don't. Have you got those presents I sent yet? I have sent you two presents since I've been here. Tell all your people to write me. From your Caffee)

Somewhere in England, Dec. 19, 1918: Dear Father, I am in England in the hospital. I have been here for almost a month. Got a little wound in the leg but will soon be ready to go back over to France. Got hit the 29th of September in the St. Quentain drive when we first started it. Our division was honored for their bravery up there, but there were not many of the whole divisions left to tell the tale. Am glad I was one of the lucky ones. I don't think it will last much longer anyway. They won't fight a hand-to-hand fight so don't think it will take us long to get into Berlin. Will get there next summer anyway if they don't quit before then. I would like to see Berlin shot up like Albert and some other towns in France. Your Son, Hugh Smith. (Son of Ernest and Marth

Somewhere in France, Nov. 20, 1919, Dear Sister, I guess you've heard the good news by this time. Ha! I don't guess it will be long till I'll get to come home. That's all the boys talk about now is coming home. I would like to get home by Christmas but I don't know whether I will make it or not. You need not worry about me now for I am fat and fine. All the boys were giving the best they had when it ended. So it's all over now. When I get to New York, I'll let you know. I heard from Guy a few days ago and he was well. I am about two miles from Paris now. It is the most beautiful place you ever saw. Give my love to all. Your loving brother, Halicy Caffee (Son of William and Myrtle

A meeting to nominate candidates for the 4th District representative on the Kentucky Fish and Wildlife Commission will be held Nov. 20 at Rough River State Resort Park, 450 Lodge Road, Falls of Rough, Ky. The meeting will start at 7:30 p.m. (Central time). Doors open at 6 p.m.

The commission provides oversight of the Kentucky Department of Fish and Wildlife Resources and guides development of the state's regulations on hunting, fishing, boating and related matters.

Resident hunters or anglers of the 4th District who, for the past 2 consecutive years, have held a Kentucky hunting or fishing license or hunted or fished in Kentucky while license-exempt under KRS 150.170. may participate in the nomination meeting. The 4th Wildlife District includes Adair, Barren, Cumberland, Edmonson, Gravson, Green, Hardin, Hart, Larue, Marion, Metcalfe, Monroe, Nelson, Taylor and Washington

counties Nominees must: be a current resident of the district; not be a convicted felon; have held hunting and fishing licenses for at least the previous 5 consecutive years or hunted and fished in Kentucky while license-exempt under KRS 150.170; and be well informed about wildlife conservation and restoration. The names of nominees chosen at the meeting will be submitted to the governor, who will appoint one of the nominees, subject to Kentucky Senate confirmation
