ADVOCATING FOR INCREASED PROTECTION OF OUR CHILDREN'S LEARNING **ENVIRONMENT**

Dear Editor,

I am writing as a deeply concerned parent and citizen of Oldham County regarding the alarming lack of protective setbacks between our schools and heavy industrial developments — particularly the potential hyperscale data centers that could be advanced near our current or future educational campuses. Our community expects and deserves stronger safeguards to ensure that the health, safety and learning conditions of our children are never compromised for industrial interests.

It is both a matter of established best practices and simple common sense that a minimum setback of 1,000 feet and ample landscape and buffer zone from the high security fence should exist between any school and heavy industrial activity. Such a standard is not excessive – is responsible. Diesel fuel storage, around-the-clock massive generator operation and testing, massive electrical substations, sustained operational noise and vibration, sustained construction noise and heightened traffic volumes create an environment wholly incompatible with education. These are not theoretical concerns; they have well-documented, measurable impacts on student concentration, respiratory health and emotional well-being. Proposed data center zoning regulations are currently being considered before the Planning and Zoning Commission on Oct. 28. Currently, a data center would be required to maintain a 1000-foot minimum setback from residentially zoned land. Unfortunately, schools have not been given this similar protection and would allow a 15foot minimum setback for any buildings, ancillary and accessory usages of a data center to our schools property line in some zoning districts.

Equally concerning are recent reports that an informational document distributed following a School Board meeting downplayed these risks and omitted critical context. The public deserves to know: who authored this document, who reviewed its contents, and whether any developers, lobbyists, or outside consultants influenced the information shared. Transparency is not optional when decisions of this magnitude affect children's daily environ-

The community also requests immediate clarification on whether any district-owned property has been, or is being, considered for sale or lease to data center developers, and whether such discussions occurred with proper public notice and board oversight. The public trust demands a full accounting of these

Finally, the comparison that has reportedly been made between hyperscale data centers and rural schools is both inaccurate and insulting. To equate industrial operations involving megawatt-scale generators, diesel storage tanks and 24/7 equipment noise with a school campus is an affront to every parent, teacher, and child in this district. Such a position reveals a dangerous detachment from the lived reality of our schools and an unacceptable disregard for

student welfare. I urge the school board to correct the record, reaffirm its duty to protect the learning environment and take formal action to support minimum setbacks that reflect the highest standards of student safety. Our children's right to a healthy, peaceful, and focused learning space must not be subordinated to corporate convenience or political influence.

The people of Oldham County are watching closely — and we expect leadership that honors both the letter and the spirit of your oath to serve this community.

Until they come home: Remembering everyone deployed

ational Day of the Deployed is this Sunday, Oct. 26, 2025. If you didn't

know this day existed, you're not alone. The celebratory day has only been an official day of recognition for 13 vears.

The day was initially started in North Dakota by Shelle Michaels Aberle in 2006 for her JOELLE KERFOOT deployed cousin, Major **BOAZ** David Hosna, on his birthday. Then, in 2011 North Dakota Governor, John Hoeven, issued a state proclamation, before sponsoring the resolution that passed unanimously the following year making the National Day of the Deployed an annual observation on Oct. 26. While it is appropriate that we have a national day to recognize deployed service members, one day a year is not enough to support them in their service for our continued freedom.

Since the early 2000s, when United States service members were being deployed heavily to the Middle East in Afghanistan and Iraq as a result of the Terrorist Attacks on Sept. 11, 2001, wearing red on Fridays has been a small way to show big

support. Red represents courage, sacrifice and valor; all qualities associated with those

that answer the call to serve our country. RED became the acronym for Remember Everyone Deployed. Over the last two

decades I hope you have seen a shirt that has the American Flag and some version of the wording, "Red Fridays", "Remember Everyone Deployed" or as my cur-

rent Friday shirt reads, "Until they all come home." While we may not be in a current conflict to the magnitude of the mid 2000s, there are still service members deployed around the world, some from right here in Oldham County. Small gestures, like wearing a red tie, socks, button-up, polo or other item on Fridays sends a big message of uniformity, support and gratitude from home and means more to the service

members than we know. Soldiers, airmen, Marines and sailors don't serve alone, their families serve right along with them. Wearing red on Friday doesn't mean something only to the service members, it matters to their families too.

10:25, Jesus answered with a story about a Jewish man in need. If Jesus had been asked the same question in 21st century America, he could have told a story about a young girl whose

parents were

abusive, a widow who lost her husband or a poor man struggling to pay rent. They are all in need, and Christians all agree that we are to love these neighbors. When we sit with a widow, adopt an orphan or help a poor man find employment, we become closely acquainted with our neighbor's need, and we can love them. But we cannot love those whom we do not know. Love requires proximity. It

always has. We must walk on the other side of the road where we find Jesus, the good Samaritan tending to his foreign neighbor's needs.

The sojourner, the stranger, the immigrant, the refugee and the permanent resident are all our neighbors. Unfortunately, legal immigrants are often

unfairly co-opted into the discussions about deporting undocumented immigrants or building a wall. They are sadly included in many critiques of immigrants' threat to public safety and concerns over taking Americans' jobs and perverting Western culture. This rhetoric has undermined our neighbors' confidence in their long-term stability in this country and has resulted in the public policies and processes that do not align with the kingdom of Christ.

Since 1980, the U.S. government has resettled tens of thousands of refugees every year. But these legal residents do not get citizenship automatically. They must wait five years as they show themselves to be good residents of the U.S. before they are eligible for naturalization. Once they are sworn in, they have all the rights and privileges of any U.S. nativeborn citizen, except for running for U.S. president. The U.S. resettlement process is
