## Forever Young flips the script in the Breeders' Cup Classic

last year's Classic just can't help themselves. The same three met again in this year's renewal and once again it came down to those same

three that would decide who's the 2025 Breeders' Cup Classic champion.

The betting public nailed it in making Fierceness, Sierra Leone, last year's winner, and **HARPER** Forever Young (JPN) all 3-1 with the slightest edge to Fierceness as the favorite according to dollars wagered to win. It shaped up once again at the head of the stretch to be the same as it ever was. Only this time, the horse from Japan got the jump on Fierceness with Sierra Leone putting in his usual late charge to grab second. Forever Young (JPN) avenged a two-race US losing streak and stamped himself as the

he top three finishers in hopped and brushed the gate at the start. The best horse clearly won the race with the same stalking trip as last year with one very

important change which was to lay second and then pounce. And pounce he and jockey Sakai did. Fierceness seemed to have some minor traffic trouble on the turn for home but made his bid, it just wasn't good

enough. Journalism threatened for a brief moment but ran a credible fourth. Mindframe, the other Todd Pletcher runner made a bid to take second but was no match for Forever Young (JPN) and settled for fifth. The poor break took its toll on Baeza and he finished sixth. Nevada Beach was a wellbeaten seventh with Antiquarian eighth and Sierra Leone's rabbit Contrary

The pace of the race was moderate to begin with an opening quarter in :23 but they picked it up consider-

ably after that with finishing fractions of :45.4, 1:10.2 for six furlongs, 1:35.3 for a mile and an excellent final time of 2:00 flat. It was a satisfying result for top Japanese trainer Yoshito Yahagi and owner Susumu Fujita. They always knew that their horse had what it took to compete with top dirt horses all over the

In April, Forever Young (JPN) was defeated again by another US horse, Hit Show in the Dubai World Cup. He then put in his Breeders' Cup prep by easily winning a race in Japan. He takes the winner's share of \$3.6 million with him back to Hong Kong. His job was made much easier after the unfortunate scratch of morning line favorite Sovereignty who spiked a fever earlier in the week. It will be very interesting to see what owner Godolphin decides is next for the 2025 Kentucky Derby, Belmont and Travers champion.

The undercard races both Friday and Saturday had some very interesting story lines. On Friday, owners Medallion Racing had a big day winning both the BC Juvenile Turf Sprint with the filly Cy Fair and the BC Juvenile Fillies Turf with Balantina (IRE) who is trained by Donnacha O'Brien, Aiden's son. Daddy O'Brien's only win of the weekend was with Gstaad in the BC Juvenile Turf. That win broke Wayne Lukas's Breeders' Cup record of 21 wins.

Super Corredora (8-1) took the BC Juvenile Fillies (Dirt). Our pick, Iron Orchard was last after stumbling badly at the start.

Our pick, Ted Noffey (4-5) took the BC Juvenile and stamped himself as the early favorite for the 2026 Kentucky Derby. Everyone is having fun with his name. He was named after one of the principals of Spendthrift Farm, Ned Toffey. He was a very impressive winner for Todd Pletcher.

Slendora, trained by Bob Baffert, got Saturday started. Our pick Sweet Azteca was scratched. Baffert had two wins on the

Shisospicy won the BC

Turf Sprint with Irad Ortiz. Ortiz led all jockeys with three wins for the two days. Our pick, Motorious was

The story of the Breeders' Cup was trainer Jose D'Angelo who won his first BC race and then followed it up with a win in the Breeders' Cup Sprint with a dominating win by Bentornado. He was our backup pick in the event Banishing (12th) opted for another race. At least we had a better BC than Aidan O'Brien.

Scylla, trained by Bill Mott was an upset winner of the BC Distaff. Only in the BC can a \$2 million race serve as a consolation prize. We'll never know if Sovereignty was up to the task. Our pick Clicquot finished fourth.

Ethical Diamond (IRE) won the \$5 million BC Turf with a huge stretch run defeating Rebel's Romance and favorite Minnie Hauk (our pick) who actually took the lead but flattened out to finish a puzzling

Our pick Notable Speech (GB) rolled home first in

the BC Turf Mile, the only win for renowned trainer Charles Appleby and Godolphin.

Our pick and best bet Nysos was all out to win the BC Dirt Mile running down Citizen Bull who set blazing

fractions. Gezora (FR) won the BC filly and mare Turf with our pick Cinderella's Dream finishing eighth.

For the most part, everything was as it normally is in the Breeders' Cup. The Euro's took care of the turf races, and the state side horses ruled the dirt. We now turn our attention to the juveniles who will turn three and set a course for Roses on the first Saturday in May of 2026, just 181 days away. We have to also tip our hats to the Japanese and Forever Young (JPN) for their persistency in pursuing America's greatest prize in racing, the Breeders' Cup Classic.

senior Ryder Roberson's rebound shot just rolled left for a goal kick. Gifford made another save off a header by Anderson a few minutes

"Having a lot of seniors, I thought we started the game off pretty well and kind of settled down and kind of went off their leadership," Cantrell said. "It can be difficult, especially the conditions [Tuesday], with it being a little wet and skippy," Cantrell said. "It kind of played into their hands where we were having trouble getting the ball down and keeping great possession. It's tough, but they played well. They were winning a lot of first and second balls."

Hayden forced a South corner, but Covington Catholic's defense held

strong to stop the attack. Roberson took a shot that was deflected by Colonel senior Matthew Witte. Covington Catholic sophomore Charlie Bakker had a shot bounce off the crossbar at the other end of the field.

The Dragons started to get back into an offensive attack with 22 minutes left regulation. South sophomore Liam Hayden had a pass from a header go to Anderson inside the box, but Anderson's shot iust went left of the goal. The Dragons stopped a corner and free kick over the next few minutes of play before they started to control the ball and pace of play again.

Hayden gave South another corner, but Gifford punched the ball out of the box. The Dragons immediately put a cross back into the box, but Anderson's header just went left of the goal. Spurlock made a tackle before dribbling the ball inside the box to take a shot. Gifford made another save to keep the game scoreless.

Over the next few minutes, Gifford kept Covington Catholic tied with a save and punching the ball out of the box on a South corner. In the final 10 minutes of regulation, both teams had chances to put the game away but couldn't convert on the opportunities. Briscoe made a save before Gifford cleared another South corner to bring the game into overtime scoreless.

"We were just trying to settle down and play the ball and possession and not just going big but settling down and finding spots in our attacking third," Cantrell said. "I thought we created some chances, and, unfortunately,

we just didn't finish them.' The Dragons dominated Hayden earned a corner possession in both overtime periods. The first overtime saw them get inside the box to no avail. In the second overtime, a shot by Anderson earned a corner that the Colonels cleared. South had two more shots that just missed to bring the game into a shootout.

Both teams made their first attempts of the shootout on points from Covington Catholic junior Cole Spaulding and Spurlock. Briscoe made a save on the Colonels' second attempt before Liam gave the Dragons a 2-1 lead. Both teams made their third attempts on shots by Copeland and Hinkle.

Covington Catholic sophomore Leo Dyas scored on the fourth attempt before Gifford tied the shootout at three apiece with a save. Robertson gave the Colonels the lead on the fifth attempt, and the Dragons missed their last attempt to give Covington Catholic a 4-3 win in a shootout in the state semifinals.
