Trump pressures GOP senators to end the government shutdown

WASHINGTON President Donald Trump lashed out Wednesday at Senate Republicans to end the government shutdown, now the longest ever at 36 days, blaming the impasse for the party's defeat in closely-watched elections while Democrats. emboldened by their offyear victories, dug in for a fight.

Trump, whose first term at the White House set the previous government shutdown record, said this one was a "big factor, negative" in Tuesday's races. He revived his demands for Republicans to end the Senate filibuster as a way to reopen government — something senators have refused to do.

At the same time, Democrats hardened their resolve after sweeping governor's races in Virginia and New Jersey and the mayor's race in New York. The Democratic leaders said Trump needs to get serious about negotiating an end to the stalemate and resolve the problem of expiring health care subsidies that are central to the debate.

The election results ought to send a much needed bolt of lightning to Donald Trump that he should meet with us to end this crisis," said Senate Democratic Leader Chuck Schumer of New York.

SKYROCKETING HEALTH INSURANCE COSTS AT ISSUE

Central to any resolution will be a series of agreements that would need to be upheld not only by the Senate, but also by the House, and the White House, which is not at all certain.

Senators from both parties are pushing to ensure the normal government funding process in Congress can be put back on track, eyeing a smaller package of bills that has widespread support to fund various aspects of government such as agricultural programs and military construction projects at bases.

More difficult, a substantial number of senators also want some resolution to the standoff over the funding for the Affordable Care Act subsidies that are set to expire at year's end.

With insurance premium notices being sent, millions of people are experiencing sticker shock on skyrocketing prices. The loss of enhanced federal subsidies, which were put in place during the COVID-19 pandemic and come in the form of tax credits, are expected to leave many people unable to



COUNTY TAXPAYERS' NOTICE

McCracken County's 2025 property tax bills will begin arriving in mail boxes November 1, 2025. Taxes will become due and payable to the McCracken County Sheriff's Office beginning on that day and will be payable based upon the following schedule:

November 1 – November 30, 2025 December 1 – December 31, 2025 January 2 – January 31, 2026 February 1 – April 15, 2026 2% Discount Face Value 5% Penalty 10% Penalty + 10% Fee

All tax bills not paid to our office by the close of business on April 15, 2026 will be transferred as delinquent to the McCracken County Clerk for further collection proceedings. Additional penalties and interest will be assessed to all delinquent tax bills paid to the County Clerk's office.

Payment Instruction: If you do not receive your tax bill within the first few days of November, you can find your bill on our office's website or contact us to request a duplicate. Office hours for receiving payments in person are from 8:30 AM to 4:30 PM Monday thru Friday. It is important to bring your tax bills with you when paying in our office. If mailing payment, please include the remit portion (bottom-half) of your tax bill and record your tax bill number on your check, made payable to the McCracken County Sheriff.

Additional Information Regarding Tax Information and Payment

Tax Bill Changes or Disputes: The sheriff's office only has the statutory responsibility of collecting the amounts charged on your tax bill. Property assessment concerns should be directed to the McCracken County Property Valuation Administrator's office, and any address changes can be made on their website at mccrackenpva.com. Concerns regarding the assessment of your 911 fee would need to be discussed with the McCracken County Judge/Executive's office.

Electronic Payments: In addition to cash and check payments, your tax bill may be paid with credit or debit card. Please note, however, a consumer convenience fee will be charged to your banking or credit card account when using electronic payment methods and will show as a separate transaction on your monthly statement. This fee is calculated as a percentage of your tax bill amount and is charged by Intellipay Payment Processing. The sheriff's office does not receive any portion of these convenience fees.

Online Payments and Bill Search: We offer the ability to view and pay your tax bill(s) online by visiting our website at mccrackencountysheriff. com and clicking on the "Property Taxes" link. The same convenience fees noted for electronic payments also apply to online payments. E-check payments are also available online and have a flat \$2.50 fee regardless of the tax amount being paid.
