# City officials have some zoning suggestions

SHEPHERDSVILLE - City officials have some ideas that they County Joint Planning Commission.

The definition for transitional housing would be "a residential facility providing temporary or intermediate-term housing for individuals or families transitioning from homelessness, institutional care not including incarceration, or recovery programs. Transitional housing may include supportive services such as counseling, case management or life skills training. It is considered residential in nature which prohibit discrimination for and distinct from boarding houses,

housing options, Dozier said there tourist camps, shelters or institutional supervision to ensure the safety, care facilities.'

Besides the definition, there were other requirements listed in the proposed text amendment. Those included:

\*all bedrooms and sleeping areas shall meet the current occupancy limitations required in any applicable building, fire or life safety code.

\*shall be a temporary housing arrangement for its residents, with stays generally ranging from 6-14 months. This is to provide a transition back into permanent housing.

welfare and orderly operation of the residence. Supervision should be defined as the presence of a designated staff member, manager or responsible party who is available on-site or on-call during operating hours. The level of supervision shall be proportionate to the number of housing facilities constructed as residents and the nature of the services provided.

\*Non-residential uses and services that are not accessory to the transitional housing use shall not be carried out unless otherwise permitted and approved as a separate use. Transitional housing that serves as recovery housing should follow best practice industry standards \*facilities should include adequate and operational rules, such as the

National Alliance for Recovery Residence (NARR) standards.

\*shall meet the health, sanitation, structural, property maintenance, fire, and life safety requirements of any currently applicable federal, state or local laws.

\*maximum density for transitional dwelling units shall be the maximum density of the applicable zoning

\*any building shall remain or shall be constructed so that the exterior design and ornamentation is residential in character and compatible with other residential architecture in the immediate neighborhood so


The flight was a life-changing event Conn and Smith will always remember and they were both very pleased to participate.

A native of Printer, Ky., in Floyd County, Conn eventually moved to Bullitt County because he had a sister here. It's where he lived when he entered the United States Army in 1962 and where he has resided and raised his family since. He previously served as a Hillview City Council member.

Conn completed basic training at Ft. Knox, then traveled to Ft. Dix in New Jersey before heading overseas. He was stationed in Germany for three years, then participated in the Reserves for another six, leaving the military as an E-4 Specialist.

The local veteran first received a call from Honor Flight last year inviting him to participate. He applied and asked Smith to serve as his official guardian for the trip (each veteran has a guardian join and assist them for the day).

The pair had a couple months to prepare for the journey, with Smith participating in guardian applications and training.
