# Shelby County candidates rush to file as election season begins

Filing for 2026 local candidates officially opened on Wednesday, Nov. 5, and several candidates rushed to the Shelby County Clerk's Office to put their names into the political hat.

Partisan offices with a primary election can file through 4 p.m. on Jan. 9, 2026. Non-partisan offices, such as city races, judicial contests and school board seats, will remain open for filing until June 2.

On the first day, two candidates for Shelbyville mayor filed, including incumbent Troy Ethington and challenger Josh Berkley.

# Thoroughbred trainer Romans enters the Kentucky Senate race

LOUISVILLE — Longtime thoroughbred trainer Dale Romans on Wednesday entered the Kentucky Mitch McConnell in the U.S. Senate, portraying himself as an independent Democrat willing to cut through "partisan nonsense" and tackle trade, health care and immigration.

Romans criticized President Donald Trump's tactics in his immigration crackdown and pointed

immigrant laborers who toil for long hours cleaning stalls and performing other labor-intensive tasks tending to horses at racetracks.

"I've traveled around the world, campaign to succeed Republican but I also saw the plight of the immigrant workforce we needed back here," Romans said in an introductory campaign video. "The ones that are here working, doing jobs that are necessary in this country. We need those people. We don't need a fight, we need a fix."

Romans said the nation's borders

to his decades of work alongside must be secured and that people to win as an underdog. living in the United States illegally back to their home countries. But raids by immigration agents under the Republican administration, he said, have created fear and resentment in targeted communities, sometimes ensnaring innocent residents while hurting businesses and the economy.

With more than 2,250 career victories as a trainer, including in the Preakness Stakes and Travers Stakes, Romans said he knows how

Romans joins a large field of who commit crimes should be sent Republicans and Democrats competing in 2026 for the Senate seat held since the mid-1980s by McConnell, who is retiring when his current term ends. Kentucky's primary election is in May.

> "We need a senator who reflects our people," Romans said in a news release. "Not polished insiders or party-line politicians running the same old partisan nonsense, but someone who has built a career the hard way and lived the struggles

that Kentucky's working families face every day."

Romans stressed his workingclass background and said he would protect workers and businesses from overregulation and "destructive" tariffs. He pledged to take action to make Kentucky more affordable. Affordability was a key issue in Democratic victories in last week's elections in places such as Virginia and New Jersey.

He said he would work to

why they decided to rezone it as I-1 when they, and the Industrial Foundation, all say there are 1,400 acres that are already zoned industrial," said Hardesty. "I would also ask the Industrial Foundation and ask them if they believe there are still 1,400 acres of industrial land and if they support the land being zoned industrial."

He explained that, through this rezoning, two industrial buildings were approved for construction without the

Shelbyville City Council's input. He believes that the rezoning set the precedent for this new situation on Logan Station Road. With that, Ethington began

the motion: "At this time, I am going to ask if anyone from the Shelbyville City Council wants to entertain a motion that the council does not accept the property was annexed from the recommendation and findings of fact and does approve the zone change from agricultural to light industrial," said Ethington.

Ethington followed up with the Fiscal Court magistrates a statement replying to recent comments made at planning commission meetings.

He stated that at a public hearing for a previous project, it was stated that the city took in property on Brunners Town Road so that they could get a water tower, and that they don't have an adequate water supply.

"And folks, that is absolutely not correct," said Ethington.

He explained that the water tower was part of a long-term plan to strengthen emergency storage and was not about acquiring any specific property; rather, the property was chosen through a series of comprehensive land studies.

He also commented on statements made during planning meetings regarding the Logan Station Road rezoning.

"It was stated that this county in the blind part of the night, and that is incorrect," said Ethington.

He stated that each and every annexation has been done directly with the county judge beforehand, meeting with him beforehand and hand-delivering

"There have been no blind or unlawful annexations under my administration," said Ethington.

The council then moved on to public comment.

"I'd like to thank the council for upholding the Planning and Zoning Commission's recommendation on this project. This would have been a disaster for all of those who live there," said John Davis, resident of

Logan Station Road. "It gives me hope that maybe we can work together as a community to save the best of what is Shelby County, it's not just people trying to protect themselves from growth, it's people wanting to have the right kind of growth," said Bonnie Burks Gray, Logan Station resident.
