

2024 LAUREL COUNTY DELINQUENT TAX LIST

NOTICE TO LAUREL COUNTY TAXPAYERS

Tony Brown, Laurel County Clerk and the Laurel County Fiscal Court, pursuant to KRS 424.130, announce that the 2024 following list of Delinquent Real Property Tax Bills (Certificates of Delinquency) are a true and correct copy that will be offered for sale September 5th, 2025. The list of Certificates of Delinquency is available for public inspection during the hours of Monday & Thursday 8:00 am – 6:00 pm. Tue., Wed. & Friday 8:00 am – 4:30 pm, at the Laurel County Clerk’s office located at 101 South Main Street Rm 203, London , KY 40741. This list may be inspected on the Laurel County Clerk’s website. The Uniform Resource Locator (URL) of the website is <https://laurel.countyclerk.us/delinquent-taxes/>. The tax sale will be held on **September 5th, 2025 beginning at 9:00 a.m. at the Laurel County Clerk’s Office**. All delinquent tax bills may be paid any day prior to the tax sale at the County Clerk’s Office during business hours by the owner of the delinquent tax bill. Payment by cash, money order, debit card and bank verified checks will be accepted. **Payments received after the tax sale has been conducted will be returned without exception.** Some delinquencies – although they have been advertised – will be excluded from the tax sale in accordance with the provisions of KRS 134.504 (10) (b). **Additional \$12.00 advertisement fee per bill will be added to the published total.** All interested participants must register, with the County Clerk’s Office by the close of business on August 28th, 2024, Pay 100% for each priority tax bill purchased, and pay a registration fee as follows. Prior year purchasers must pay \$5.00 per bill for a purchase of 50 bills or less. Prior year purchasers of more than 50 bills must submit a registration fee of \$250.00. **A check in the amount of not less than 25% of the total price of the purchase list must accompany registration.** Purchasers of current year bills who have no prior year claims must pay \$10.00 per bill for purchases of 25 bills or less or \$250.00 if purchase list exceeds 26 bills. The sale will be conducted in a manner similar to a professional sports draft in accordance with the provisions House Bill 262 enacted by the 2009 General Assembly. The following methods of payment will be accepted by the Clerk’s office from third party purchasers. Prior year purchasers may pay by company checks at close of sale. First time purchasers pay by cashier check or money order at the close of sale. **(Do not attempt to buy bills if you are not prepared to pay immediately.)** Final payment is required **IMMEDIATELY** after conclusion of the sale. Failure to pay will result in your bills being offered for resale. If you have any questions you may contact the Laurel County Clerk’s office at (606) 864-5158.
