A Revealing Or A Warning?

Isaiah 46: 9-10 "Remember the former things of old: for I am God, and there is none else; I am God, and there is none like me. Declaring the end from the beginning, and from ancient times the things that are not yet done, saying, My counsel shall stand, and I will do all my pleasure."

If you wanted to convince someone of the reality of the Gospel of Jesus Christ, would it be logical to "beat that person over the head with a Bible" until they confessed and repent-

Of course we all know the answer to that question. Coercing someone into believing may get a required verbal response but would that person really believe?

I well remember an older cousin and hunting/fishing When I was a teenager in the 1960's he made a very astute observation. "If I paid you a million dollars to believe something, you may say you believe it, but would you really?"

What is true belief? Faith gives us a belief method that is required for eternal salvation (Ephesians 2: 8). Faith is believing in something we cannot prove. How much evidence would be required to establish proof?

What can we actually prove? Can you prove you'll be alive one minute from now? Can you prove your vehicle will start the next time you turn the key or push the button? So many of life's concepts are based on faith and trust that we do not think about.

As we consider the world events of the last few weeks, we find the parallel of Bible prophesy and those events to be beyond coincidence.

Matthew 24: 7 "For nation shall rise against nation, and kingdom against kingdom: and there shall be famines,

and pestilences, and many of the lower 48 earthquakes, in divers places."

Earthquakes in diverse places? Being from the (almost) center of the US, I would definitely classify the earthquake off coast of Russia between Russia and Alaska as a diverse place.

Luke 21: 25 "And there shall be signs in the sun, and in the moon, and in the stars; and upon the earth distress of nations, with perplexity; the sea and the waves roaring;" The resulting tsunami from the 8.7 magnitude earthquake under the sea would surely qualify for this verse from

The situation in Gaza at this time definitely fits the "famine" condition as stated by Jesus in Matthew 24: 7. Mass starvation is an accelerated state of existence for the Gazans and is now being classified as a human disaster.

Gaza is at the forefront of news outlets and it is being used as a political punching bag. This in itself is a verification of the divisions in humanity as stated by Jesus (Mark 3: 25). Gaza is not the only place on earth where famine conditions ex-

Of course we do not know exactly what Jesus was referring to as "pestilences" but it could be anything from an insect infestation to the Covid 19 virus.

The world is also experiencing a large number of active volcanos at this time. Geologists tell us that volcanos and earthquakes are directly connected. Several mountains in the northwestern United States are rumbling and some believe eruptions are a possibility in the near future.

The City of Sturgis, Kentucky is currently seeking a qualified individual to fill the position of full-time Fire Chief. This is a skilled work position involving the protection of life and property and the administration, supervision, command, and technical oversight of the city fire department. The duties of this position are performed under the general supervision of the Mayor.

Applicants must be at least twenty-one (21) years of age and possess a valid driver's license with an acceptable driving record. Candidates must be U.S. citizens, possess a high school diploma or GED equivalent supplemented by ten (10) years of experience as a firefighter, (experience in a command position is preferred), and, certification as an Emergency Medical Technician (EMT) or the ability to obtain EMT certification within 12 months of the date of hire. Applicants must also possess excellent organizational, administrative, and oral and written communication skills with a strong attention to detail. Knowledge of methods of firefighting and fire prevention is essential, as well as, knowledge regarding the use of departmental equipment including vehicles, radio, ofice equipment, fire/EMS equipment, and apparatus. The ability to analyze situations and act quickly and eficiently under highly stressful situations is essential. The successful candidate must meet the physical ability requirements as may be required from time to time by the state fire commission for similarly situated firefighters, and must live within a five (5) mile radius of the City of Sturgis

This position is a salaried position and starting salary will be commensurate with the experience and qualifications of the individual. It is anticipated the work hours will be from 7 am until 4 pm, Monday through Friday, with additional hours as required without additional compensation. The position qualifies for full employee benefits, including health, dental, vision, and life insurance, state retirement, vacation and other paid time of pursuant to the city's policies. CHILD FIND FOR CHILDREN WITH DISABILITIES IN NEED OF SPECIAL EDUCATION **OR 504 SERVICES**

Child Find

The Union County Public School District keeps educational records in a secure location in

The Union County Public School District obtains written consent from a parent or eligible student (age 18 or who is attending a postsecondary institution), before disclosing personally identifiable information to an entity or individual not authorized to receive it under FERPA.

For students who have been determined eligible for Special Education, educational records will be destroyed at the request of the parents when they are no longer needed to provide educational programs or services. The Union County Public School District may destroy the educational records of a child without parent request three (3) years after they are no longer needed to provide educational programs or services. Parents are advised that data contained in the records may later be needed for Social Security benefits or other purposes. The Union County Public School District may retain, for an indefinite period of time, a record of the student's name, address, telephone number, grades, attendance records, classes attended, grade level completed, and year completed

Children eligible for Special Education include those children with disabilities who have autism, deaf-blindness, developmental delay, emotional-behavior disability, hearing impairment, mental disability, multiple disabilities, orthopedic impairment, other health impairment, specific learning disability, speech or language impairment, traumatic brain injury, or visual impairment and who because of such an impairment need Special Education services.

Children eligible for 504 services include those children in a public elementary and secondary education program who have a current physical or mental impairment that currently substantially limits some major life activity which causes the student's ability to access the school environment or school activities to be substantially limited.

Children eligible for the State-Funded Preschool program include three- and four-year-old children identified with disabilities and four-year-old children who are at-risk, as defined by federal poverty levels up to 150%. Preschool children eligible for special education must have an Individual Education Plan (IEP) instead of a 504 plan to receive State-Funded Pre-

The Union County Public School District has an ongoing "Child Find" system, which is designed to locate, identify and evaluate any child residing in a home, facility, or residence within its geographical boundaries, age three (3) to twenty-one (21) years, who may have a disability and be in need of Special Education or 504 services. This includes children who are not in school; those who are in public, private, or home school; those who are highly mobile such as children who are migrant or homeless; and those who are advancing from grade to grade, who may need but are not receiving Special Education or 504 services

The district's "Child Find" system includes children with disabilities attending private or home schools within the school district boundaries who may need special education ser-

The Union County Public School District will make sure any child enrolled in its district who qualifies for Special Education or 504 services, regardless of how severe the disability, is provided appropriate Special Education or 504 services at no cost to the parents of the child.

Parents, relatives, public and private agency employees, and concerned citizens are urged to help the Union County PublicSchool District find any child who may have a disability and need Special Education or 504 services. The District needs to know the name and age, or date of birth of the child; the name, address, and phone number(s) of the parents or guardian; the possible disability; and other information to determine if Special Education or 504

Letters and phone calls are some of the ways the Union County Public School District collects the information needed. The information the school District collects will be used to contact the parents of the child and find out if the child needs to be evaluated or referred for Special Education or 504 services

If you know of a child who lives within the boundaries of the Union County Public School District, who may have a disability, and may need but is not receiving Special Education or 504 services, please call 270 or send the information to:

"Child Find" activities will continue throughout the school year. As part of these efforts the Union County Public School District will use screening information, student records, and basic assessment information it collects on all children in the District to help locate those children who have a disability and need Special Education or 504 services. Any information the District collects through "Child Find" is maintained confidentially.

Written Policies and Procedures have been developed which describe the District's requirements regarding the confidentiality of personally identifiable information and "Child Find" activities.
