I am posting my email address below, so please feel free to share your answers with me. Let's begin with hope. Forget human limitations, use your imagination, the sky is the limit! What do you want for Christmas regarding HOPE?

Oh, God knows there are many things I'm hoping for. However, this year I'm hoping for a breakthrough on dementia - Alzheimer's, vascular, Lewy Body, CTE, or frontotemporal. I have witnessed firsthand the debilitating and insidious nature of this disease in close family members. The toll it takes on its victims and their loved ones is devastating on many levels. The last few years, I have worked hard spiritually, emotionally, and mentally to rid myself of hate. Hating people, groups, etc. However, I hate dementia! My hatred for it has only grown stronger as I've watched loved ones suffer and die from it. My hatred for it has blossomed by witnessing what it has done to caregivers I love, respect, and admire.

Dementia is death by inches. Every day, week, month, and year that passes steals more joy, dignity, peace, and patience from the afflicted and their family, most notably primary

caregivers. Watching loved ones behave in ways they would never do so in their right mind is gut-wrenching. I've walked away from more visits and phone conversations asking God, "Why?" so many times. I've pleaded for Him to end the suffering. And I weep when there is no answer. I've been fist-shaking angry at God about it. One night, I actually screamed at Him because of the pain it was causing someone I love very much, a primary caregiver. I have grieved for her as much as I have for our loved one. This isn't right, it's not fair! No one deserves this.

One of the most intelligent, critical-thinking men I ever knew and loved suffered the ravaging results and brain theft from Alzheimer's. A man whose name still appears on many electrical engineering-related patents was reduced to watching reruns of the Game Show Channel. He was so intelligent that he could do NY Times crossword puzzles in his sleep. He loved them, and the more difficult the better. I remember sitting with him several years into the disease. He had his ever-present puzzle book in hand as we watched TV. He had worked on it for a couple of hours but hadn't turned the page. He got up to go into the kitchen, and that's when I saw the empty crossword puzzle with his pencil tucked inside. He had been staring blankly at the book for hours. I cried so hard that night in bed. This hero of mine had crossed an unthinkable boundary. In just a few short years, he went from independent to assisted living and finally memory care. This wonderful husband and loving father of seven children, a proud war veteran, and brilliant engineer, could not survive the mind-gobbling disease. Death was a cruel relief.

One thing I know, ALZ did not and could not separate Dad Mills from the love of God in Christ, Jesus! (Romans 8:35-39) I loved him and still do!

I am HOPING: somewhere, somehow, a team of brilliant scientists and researchers will find a cure or significant treatment for dementia. This is my hope for Christmas 2025. What is yours?

# Voter Registration Increasing In State

Secretary of State Michael Adams announced that voter registration continued to grow in November, despite no state elections in the off-year.

"Despite the exhaustion many voters now feel with this era of politics, that has not stopped them from registering to vote in significant numbers, even in a year when we don't vote," Adams said.

In November, 3,748 voters were removed: 2,982 who were deceased, 385 felony convicts, 259 who moved out of state, 65 adjudged mentally incompetent, 26 who voluntarily de-registered, 19 duplicate registrations, and 12 non-citizens.

Republican registration constitutes 48 percent of the electorate, with 1,595,408 voters. Republican registration grew by 2,412 voters, a .15 percent increase. Democratic registration accounts for 41 percent of the electorate, with 1,379,958 voters. Democratic registration fell by 1,914, a .14 percent decrease. There are 371,955 voters registered under other political affiliations (mostly independent), making up 11 percent of the electorate. "Other" registration rose by 1,209, a .33 percent increase.


