AN ORDINANCE ACCEPTING THE 2025 TAX ASSESSMENT; IMPOSING AD VALOREM TAXES; PROVIDING A DUE DATE FOR PAYMENT OF TAXES AND PENALTY AND INTEREST FOR THE UNPAID TAXES, ALL FOR THE YEAR 2025

#### SUMMARY

This is an ordinance accepting the 2025 tax assessment, levying an ad valorem property tax on all real and personal property except motor vehicles and boats, providing for a tax due date of December 12, 2025, and fixing penalty and interest for late payment on unpaid taxes.

SECTION 2. That an ad valorem tax rate of 12.30 cents is hereby levied and imposed for the year 2025 upon each One Hundred Dollars (\$100.00) of assessed value of all real property of whatever kind, species or description (except motor vehicles and hosts as to which a tax has been

description (except motor vehicles and boats as to which a tax has been imposed heretofore in Ordinance Number 21-2025) subject to taxation. SECTION 3. That an ad valorem tax rate of 15.55 cents is hereby levied and imposed for the year 2025 upon each One Hundred Dollars (\$100.00) of assessed value of all personal property of whatever kind, species or

of assessed value of all personal property of whatever kind, species of description subject to taxation.

SECTION 4. The 2025 taxes shall be due and payable to the City of Winchester on or before the twelfth day of December 2025. Tax bills not paid on or before December 12, 2025, shall be assessed a penalty of ten percent (10%) in addition to interest at the rate of six percent (6%) per annum on the unpaid balance until paid.


