The Clark County Fiscal Court held its most recent meeting on Tuesday, November 12. At that meeting, minutes from the Oct. 23 and Nov. 5 meetings were approved. The items are of the official

THURSDAY, OCTOBER 23:

With the exception of Magistrate Mark Miller, all magistrates and Clark County Judge-Executive Les Yates were present.

- Motion made by Magistrate Dan Konstantopoulos, seconded by Magistrate Steve Craycraft, to approve HCAA (Health Care Administrators Association) for stop loss insurance once the county has reviewed, and to renew the ancillary benefit and have the county judge sign all documents. The

vote passed unanimously. - Motion made by Magistrate Chris Davis, seconded by Magistrate Craycraft, to approve Order 2025-121 approving a \$1 pay increase for all hourly firefighters in the Clark County Fire Department, effective October 23, 2025. Magistrate Robert Blanton voted no. Motion carried 5-1.

- Motion made by Magistrate Davis, seconded by Magistrate Ernest Pasley, approved a pay rate increase for part-time firefighters in the Clark County Fire Department to \$13.00 per hour. The vote passed unanimously.

- Motion made by Magistrate Konstantopoulos, seconded by Magistrate Pasley, voted to approve a joint resolution, Resolution 2025-11, between Clark County and the City of Winchester supporting the completion of the Winchester Eastern **Bypass-Southeast**

Corridor. Motion passed unanimously.

- Motion made by Magistrate Blanton, seconded by Judge Yates, to consider an order approving a salary for EM (Emergency Management) Director. Motion rescinded.

- Motion made by Magistrate Pasley, seconded by Magistrate Craycraft, for the Clark County Judge-Executive's office to submit a bid notification for the Ecton Road paving with state specs to the Winchester Sun by the end of the day on October 28th for advertising on Saturday, November 1, for bid opening on November 7,

- Motion made by Magistrate Craycraft, seconded by Magistrate Blanton, to amend the aforesaid motion to strike out "Effective July 3, 2025" and "Whereas Perri Wilson has served in this position without pay beginning July 3, 2025, to present date, she shall receive back pay for the hours worked without pay to present date of November 5, 2025." 
the county judge can provide loan options with KACO and have communication with the best equipment company for two invoices, and to check on the warranty.
