LEXINGTON, Ky. - It's time to sock it to blood shortages. To do that, donors in our community can step up and do their part this Saturday.

Local donors can put their feet up and donate blood at the Kentucky Blood Center drive scheduled tomorrow at the Wolfe County Fire Department in Campton.. All donors will receive a two-pack of socks (while supplies last) as a thank you for boosting the blood supply.

The drive will be frolm 9:00 a.m. to 1:30 p.m.

Stocking the shelves is important for the 70-plus hospitals Kentucky Blood Center provides blood to. The upcoming winter season can disrupt blood collections with weather cancellations and an uptick in illnesses.

Donating blood is easy. Whole blood donations take less than an hour from regis-



tration to refreshment, and the blood collection process only takes 8-12 minutes. One hour at this KBC drive could save up to three local lives.

Blood donors must be at least 17 years old (16 with parental consent), weigh at least 110 pounds, be in general good health, show a photo I.D. and meet additional requirements. Sixteen-year-old donors must have a signed parental permission slip, which can be found at kybloodcenter.org.

Schools prepare for increased student need following SNAP cuts

Family resource centers brace for impact as food pgm. ends for families

Oct. 28 — School districts across Eastern Kentucky are preparing to serve more students in need after the announcement that SNAP assistance benefits are at risk, with family resource centers bracing for a significant increase in demand.

'As soon as I heard, all these faces flashed through my head, then all these family homes flashed through my head," said Julie Rogers, the family resource center coordinator for Red River Valley Elementary in Wolfe County.

Family resource centers across several Eastern Kentucky schools are preparing for the impact after people stop receiving their SNAP benefits.

'We have grandparents raising grandkids, other family members raising kids. They are providing those needs that they didn't sign up for but they're still taking on, and now we are cutting the benefits that they desperately rely on, its going

to be a big issue. It already is a big issue," said Rogers.

Rogers said the holiday season is already busy for her in preparing to feed kids over holiday breaks, but they're already looking to get extra help from local pantries to meet increased need.

student advisory council is organizing a food drive to help students who may be impacted.

"And we are actually going to get a resource sheet for our families to send out with all the food pantries and everything like that on it, and we just hope we can reach the ones that we need to reach," Donithan said.

Both Rogers and Donithan said they're grateful for the local food pantries and churches that are stepping up to help them help kids during this time.

SNAP work reporting requirements are expanding: what Kentuckians should know

Even if their SNAP cards don't work at the grocery store because of a political stalemate in Washington D.C., most Kentuckians receiving federal food benefits will have to start submitting proof of work this month, even as the federal government stays shut down.

Effective Nov. 1, veterans, the homeless, recent foster care youth and adults ages 54-64 are no longer exempt from work requirements to receive food benefits for themselves and their families through the Supplemental Nutrition Assistance Program (SNAP).

policy experts say.

The expanded work requirements, mandated by the One Big Beautiful Bill Act, are expected to cost 114,000 Kentuckians their food assistance,

Work reporting requirements are not new, but the sweeping budget bill passed by Congress this summer expanded who has to abide by them.

In Kentucky, the impact will be "substantial," says Cabinet for Health and Family Services spokeswoman Kendra Steele.

Under previous rules, SNAP recipients in 117 of Kentucky's counties - most of the state

were exempt from work reporting requirements due to the local unemployment rates, Steele said.

Now, people who get SNAP benefits in all 120 counties will have to comply with the new work and reporting require-

They and new applicants who meet the following criteria will be required to work or participate in Kentucky's Employment and Training program for at least 80 hours a month:

The recipient is age 18 through 64 years and 11 months, an expansion from the previous age range of 18–54.

The recipient is not living with a dependent child under the age of 14, down from the previous standards of under 18.

The recipient is not working at least 80 hours per month.
