Household Hints

√Spots of mildew on wooden furniture or upholstered furniture can be removed by a soaked in white vinegar.

√Feather pillown and down filled comforters can be fluffwd by placing them in the sunshine for 2-3 hours or placing them in the clothes dryer on air fluff (no heat) cycle for about 15 minutes.

√Hold a cotton ball or a facial cotton round soaked with hydrogen peroxide on a mosquito bite for 5 minutes to releive the itching, burning, and the whelt should disappear. Be careful not to spill any peroxide on colored clothing or upholstery as it will remove the color. As an alternative, a dab of toothpaste will also help the itching and burning.

√Clean and refresh lined or unlined draperies by placing a panel at a time in the dryer on air dry (no heat) cycle along with a wet terry cloth washcloth soaked with a capful of liquid Woolite and run the dryer air dry cycle for 10 minutes. Be sure to wring out the washcloth before placing in the dryer.

√One-half cup of Dawn dishwashing liquid mixed with 1 gallon of water is a great window cleaner. Soak the window and squeege off. Wipe dry with a clean soft microfiber towel.
