said, the "sister wanted some action." Judge Phillips

clarified that there was no desecration of the corpse in this case, but that because Jackson failed to notify anyone of the passing in a timely manner his negligence amounted to abuse of a corpse. The unlawful contact with his victim.

Phillips sentenced Elizabeth Moore to a total of seven years on charges of first degree trafficking in methamphetamine, three counts of endangering the welfare of a child, facilitating organized crime, and tampering with physical evidence. In other action closing out the month, Phillips accepted changes of plea from Sherman Henderson, sentencing him to a total of two years and one day on charges of first degree wanton endangerment, second degree disorderly conduct, menacing, and resisting arrest.
