I have been appointed by the Court as the Warning Order Attorney in this action solely for the purpose of providing this notice to you. I do not represent any party to this action.
Deborah Mann and any Unknown Defendants, the Unknown Heirs of Clint Stephens, who wish to give notice of their intent to answer this lawsuit, should contact Mr. DeHart as soon as possible in order that he may notify the Court of their intention to defend this claim against them.
The purpose of this notice is to advise you of the existence of this claim which has been filed against you and to notify you that you have the right to file an answer to this civil action, to make an appearance in the action, and to defend yourself according to law.
Any answer you make in response to this complaint should be filed with the Clerk of the Russell Circuit Court whose address is Russell County Judicial Center, 202 Monument Square, Suite 106, Jamestown, Kentucky 42629. If no answer is filed with the Court within fifty (50) days after the date of the issuance of the Warning Order, which directed me to send you this notice, then the action against you may proceed accordingly. The Warning Order was issued on the 12th day of February, 2025, and the 50 day period began running at that date. The Court has the authority upon the issuance of a rule to shorten that time period. If you fail to respond to the Complaint by filing a written defense or response, then a judgment may be taken against you without further notice, and your right to appeal any decisions or judgments of the court may be lost.
