### **NOTICE**

In accordance with the provisions of HB44 enacted by the 1979 Kentucky General Assembly and KRS 132.023, a public hearing has been set by the Russell County Public Library Board of Trustees for September8, 2025, at the Russell County Courthouse, Fiscal Courtroom, at 9:00 am. The purpose of the hearing is to hear public comment upon the Real Property tax rate remaining unchanged at 5.9 cents per \$100 of value and lowering the Personal Property tax rate to 6.76 for 2025.

The Library adopted the compensating rate in 2021, lowering the tax rate from 6.3 cents to 6.2 cents. The compensating tax rate was taken in 2022 and lowered again to 5.9 cents. The tax rate has remained unchanged since 2022.

The tax rate for 2024 was 5.9 cents per \$100 of value with expected revenue of \$704,592, however the actual revenue produced was only \$657,193, a shortfall of \$47,399.

The proposed tax rate for 2025 will remain unchanged at 5.9 cents. The expected revenue for that rate is \$750,955. The compensating rate is 5.7 cents with an expected revenue of \$725,499. The expected revenue from New Property is \$10,115. The Personal Property tax rate will be lowered from 6.83 cents to 6.76 cents per \$100 of value with expected revenue of \$113,081. An increase in revenue is not necessarily expected, though any increase will be allocated to the increasing costs of utilities, insurance, personnel, and materials.
