Items that will be accepted include document shredding; tires (limit 8 per household); bulk/large items; used oils, antifreeze,

latex paint; hazardous household waste; fluorescent lamps & bulbs; old prescription drugs & thermostats; and computers (SmartPath Technologies on-site for secure hard drive wiping). MC Fiscal Court Recognizes Softball Team; Hears from Roger Ford

The Marshall County Fiscal court held its meeting on July 22, 2025 where the Lady Marshals Softball Team were recognized as a part of the court's ongoing

effort to recognize students in the community for their efforts both in athletics and in the classroom. The softball team not only won the regional tournament, but is also the fourth Lady Marshals team to do so. The team was also the first Lady Marshals team to beat McCracken County High School in

McCracken County the regional finals.

Following the recognition of the softball team, the court heard from Roger Ford, who is the Marshall County Jailer. Ford addressed the court about the same topic he spoke on at the July 1 meeting, requesting to take the funding from an unfilled deputy jailer position to give raises to other jail employees. Ford does not want to eliminate the position, but would rather redirect funding from his medical budget to fill that position if needed, and to replenish the medical funds from the commissary. A thorough discussion was held and it was determined by the court that, should the suggestion be approved, the best way to do it would be to eliminate the position on paper in order to adjust the funding and approve an appropriations transfer, but allow Ford to continue the recruiting efforts. If Ford found an applicant to fill the position,

the court could then amend the

budget to reinstate that position and it be funded by Ford's suggestion. A motion was made by Marty Barrett to eliminate the position and transfer the funds but the motion died due to lack of a second. When pressed as to why no commissioner offered to second the motion. Eddie McGuire, the District One Commissioner and a former sheriff, said he believed the conversation should have been had sooner. Ford stated that the approved budget was very different from the budget requests he had submitted earlier in the year. Erica West, the County Treasurer noted, that as discussed at the July 1 meeting, jails generally do not generate revenue for counties, and with the loss of Graves County inmates, the Marshall County jail should anticipate considerably less income in the 2025-2026 fiscal year in comparison to recent years.

The court then heard from Bryan Cutsinger, the Ambulance Service Director, where he requested the court approve a letter for the ambulance service to submit to their governing board. It was said that this letter serves as a waiver because existing regulations require 25% of staffing on each shift to be a paramedic, and due to various staffing issues that number cannot always be met. This waiver would prevent the ambulance service from incurring a fine if that requirement was not met. Cutsinger did note that the department currently has "adequate staffing," however there is currently one paramedic

off on medical leave. Cutsinger stated that he intended for the waiver to be an option to avoid the fines if an issue did arise but he still has every intention of fulfilling the staffing requirements. The court did go on to approve the request from

Curtsinger. The court also heard from Curt Curtner, the Emergency Management Director, who shared that Kentucky Emergency Management had developed a statewide mutual aid agreement between every county emergency management agency. The agreement is approved by the Kentucky League of Cities, Kentucky Association of Counties, and Kentucky Emergency Management. During the meeting, the court also approved the advertisement for bids for sheriff's office trucks, a road department tractor and mower, and for the judicial building janitorial services as well as the surplus of a road department culvert via sealed bids and parks department polaris and cub cadet vehicles via GovDeals. The renewal of an agreement between Mike Miller Park and Dynamo soccer saw no changes from the previous year and was also approved during the meeting. The court approved a bid from Jim Smith Contracting for the New Hope Road bridge project as well, but is pending approval from Kyle Poat with the Kentucky Transportation Cabinet. The next Marshall County Fiscal Court meeting is set for August 5, 2025 at

MURRAY, Ky. (KT) – Murray State University is celebrating the close of its historic Be Bold: Forever Blue and Gold centennial campaign, which exceeded the goal of \$100 million with a final total of more than \$107.8 million raised for the future of the university

After seven years of dedication and generosity, the campaign officially concluded on June 30, 2025, with participation from close to 25,000 donors, including alumni, faculty, staff, community members, family of alumni, businesses and organizations and other friends of the University.

Dr. Ron Patterson, Murray State's 15th President, extended his sincere gratitude and appreciation to former President Dr. Bob Jackson, the Be Bold National Campaign Council, Assistant Vice President of Advancement Dr. Tina Bernot and the thousands of alumni, partners, faculty, staff and other friends who came together to make the campaign an overwhelming success.

"Our Racer community has truly come together and shown their love for this great University and their dedication to ensuring its continued excellence and modernization," said Patterson. "Our alumni and friends care so deeply about the students of today and tomorrow and are committed to doing their part to make sure that their Racer experience sets them up to be successful professionals, good citizens and lifelong learners. I'm excited to work with the University community as we now begin to fulfill these donors' intentions and use their support to make the campaign's vision a reality in the coming years."

Half of the support raised will fund student scholarships, enabling the University to continue to keep the priority of making a Racer education accessible to all deserving students. Donors have established hundreds of new scholarships in numerous academic areas, many of which will directly support first-generation students and those with financial need

Already, the campaign is making an impact on the campus and its students. Last year, Murray State students benefitted from a record \$136 million in scholarships and financial aid. Recently, the University used funds raised in the campaign to purchase a new professional-grade performance Steinway Grand Piano to support the Department of Music. In addition, when the Jackson Hall nursing building opens its doors in fall 2026, it will be furnished with top-of-the-line modern equipment and technology.
