Sealed bids for the Louisa Middle School Sidewalk project for the City of Louisa, will be received at the City Hall located at 215 North Main Street, Louisa, Kentucky until 2 p.m., Local Time, 19th day, February 2026 and then publicly opened and read aloud.

The program of work for the project which bids are to be submitted consists of the installation of approximately 924 lf of concrete sidewalk along Gene Wilson Boulevard and Meadowbrook Lane. Additionally, drainage and pavement improvements are included.

Bidders and DBE subcontractors must be prequalified with the Kentucky Transportation Cabinet and possess a Certification of Eligibility at the time of the bid opening. All other subcontractors must be prequalified when accepting subcontracts.

Project will follow the current edition of the Kentucky Standard Specifications for Road and Bridge Construction

Bidding Documents also may be examined at City Hall, 215 North Cross Main, Louisa, Kentucky on Mondays through Fridays between the office hours of 9 am to 4 pm.

Printed copies of the Bidding Documents may be obtained from the issuing office upon a non-refundable payment of \$250. Checks for Bidding Documents shall be payable to Bluegrass Engineering, PLLC.

Upon request and receipt of the document amount indicated above, plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

All bids must be made on the required Bid Form and must be fully completed and executed with original signatures and corporate seals. A mandatory pre-bid conference will be conducted for this Project. Project will be held on site (St Jude Catholic Church Louisa, KY 38° 5'37.43" N, 82°36'5.03" W) on February 6th at 2 pm

The contract is being funded by a KYTC Transportation Alternatives Grant. Prevailing Wage Rates apply for this project. There is a 0% DBE goal for this project.

Hearing impaired individuals may call 1-800-247-2510 for information. No Bidder may withdraw his Bid within one hundred and twenty (120) days after the actual date of bid opening.

Bidders on this work will be required to comply with Title VI of the Civil Rights Act of 1964, the Anti- Kickback Act, and the Contract Work Hours Standard Act. Bidders must comply with the President's Executive Orders No. 11246 and No. 11375 and any amendments or supplements to those Executive Orders.

Attention of bidders is particularly called to the requirements as to conditions of employment to be observed under the contract, Section 3, Segregated Facility, Section 109 and E.O. 11246.

Bidders must certify they do not and will not maintain or provide for their employees any facilities that are segregated or based on race, color, creed, or national origin.

Minorities and small businesses are encouraged to submit bids on this project.
