ORDINANCE NO. 1484, SERIES 2026

AN ORDINANCE RELATING TO:

AN ORDINANCE RELATING TO AMENDMENT OF ORDINANCE NO. 1242, SERIES 2008, AS AMENDED, AND REVISING/UPDATING SECTION 208.1 OF THE JEFFERSONTOWN, KY CODE OF ORDINANCES, AMENDING, REVISING AND UPDATING THE JEFFERSONTOWN, KY PROPERTY MAINTENANCE CODE

WHEREAS, pursuant to KRS 83A.060(5) the City of Jefferson-town, Ky. has adopted a Property Maintenance Code; and,
WHEREAS, since said adoption by Ordinance No. 1242, Series 2008, as amended, additional definitions have become necessary; and,
WHEREAS, updates are needed to the Property Maintenance Code; and,
WHEREAS, the City Council finds that certain changes to the Property Maintenance Code will improve properties in Jefferson-town, Ky.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF JEFFERSONTOWN, KY:

Section 203. Exterior Property Areas

203.16. It shall be unlawful and a violation of this code for a commercial property to fail to provide adequate on-site parking to meet the demand created by the use of the property and cause over-flow parking to use parking on nearby properties or otherwise interfere with nearby properties without the consent of the nearby property owners.

Section 208. Public Nuisance

Section 208.1.1 DEFINITIONS is hereby amended to add thereto the following provisions, which shall be set forth in the Property Maintenance Code, to wit:

208.1.1. **Definitions:** For the purpose of this section, Public Nuisance shall mean any premises or place where law enforcement officers have, on more than one occasion in the preceding 12 month period, criminally cited or arrested persons or executed court issued search warrants for violations of the law governing any of the following: controlled substances, alcohol or gambling

- (1) Prostitution and/or human trafficking offenses under KRS Chapter 529;
- (2) Sexual offenses under KRS Chapter 510 with the exception of KRS 510.150;
- (3) Gambling offenses under KRS Chapter 528;
- (4) The sale or use of alcoholic beverages on or from either licensed or unlicensed premises;
- (5) Misdemeanor or felony possession, trafficking, or manufacturing drug offenses under KRS Chapter 218A;
- (6) Murder under KRS 507.020 and manslaughter under KRS 507.030 and KRS 507.040;
- (7) Assault or related offenses under KRS Chapter 508;
- (8) Theft offenses under KRS Chapter 514;
- (9) Drug paraphernalia offenses as defined by KRS 218A.500 and KRS 218A.510;
- (10) Unlicensed massage therapy under KRS 309.353;

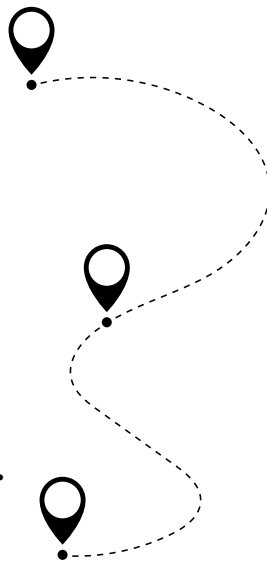
