AN ORDINANCE IMPOSING A TEMPORARY MORATORIUM ON THE CITY'S APPROVAL OF ZONING MAP AMENDMENTS, DEVELOPMENT PLANS, SITE PLANS, AND PERMITS RELATED TO DATA CENTERS IN THE CITY OF SHEPHERDSVILLE, KENTUCKY.

SUMMARY

SECTION ONE: Sets forth that a temporary moratorium is hereby imposed on the establishment, expansion, or construction of Data Centers within the City of Shepherdsville.

SECTION TWO: Sets forth the definition for “Data Centers.”

SECTION THREE: Sets forth that the moratorium shall remain in effect until the City reviews, evaluates, and adopts the forthcoming joint zoning regulations

SECTION FOUR: Sets forth the severability clause.

SECTION FIVE: Sets forth the repeal of prior ordinances in conflict with this ordinance.

SECTION SIX: Sets forth the publication requirement.
