PUBLIC HEARING NOTICE

Notice is hereby given that a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986 (the "Code") will be held telephonically at 11:00 a.m. Eastern Time on February 3, 2026, by the Kentucky Bond Development Corporation (the "Issuer"), concerning the proposed issuance, in one or more series or sub-series, at the same or different times, as part of a plan of finance by the Issuer, for the benefit of Baptist Health Deaconess Madisonville, Inc. ("BHDM"), a Kentucky not-for-profit corporation and an organization described in Section 501(c)(3) of the Code, of up to \$125,000,000 aggregate principal amount of the Issuer's Hospital Revenue Bonds, City of Slaughters, Series 2026A (Baptist Health Deaconess Obligated Group) (the "Bonds"), in accordance with a resolution or resolutions of the Issuer.

The proceeds of the Bonds in the respective maximum principal amount of \$125,000,000 will be used by BHDM for (i) financing or reimbursing a portion of the costs of the purchase, acquisition, construction, enlargement, remodeling, renovation, improvement, furnishing, or equipping of the hospital and related health care facilities owned or operated by BHDM or Baptist Health Deaconess Medical Group, Inc. ("BHDG"), an affiliate of BHDM and an organization described in Section 501(c)(3) of the Code, generally located at or adjacent to 900 Hospital Drive, Madisonville, Kentucky 42431, (ii) fund a debt service reserve fund, (iii) to fund capitalized interest, (iv) to fund working capital, and (v) to pay costs of issuance of the Bonds.

The Issuer, at the request of BHDM, reserves the right to issue Bonds under the above-described plan of financing for less than all of the above-described purposes or in an aggregate amount less than the maximum aggregate amount shown above.



Webster County Jailer's Report

Webster County Jailer Greg Sauls reports inmates worked a total of 1816 hours between January 4 and January 10, 2026. Hours worked include 520 hours at the detention center; 280 hours at the RCC; 80 hours mowing; 360 hours for Union County; 40 hours for the city of Clay; 40 hours for the city of Dixon; 160 hours for the city of Providence; 40 hours for recycling; 40 hours for the road department shop; 40 hours for the dog warden and 16 hours for Landon's Hope.

The total jail population is 167 with 40 county inmates; 27 Union County inmates and 100 state prisoners.

Department of Corrections programs attendance includes 20 attendees of the Moral Recognition Therapy program with four graduates; 21 attendees in the Anger Management program with two graduates; 26 attendees in Thinking for Good and 21 attendees in Untangling Relationships. Nine inmates took part in GED Classes.
