Union County Fiscal Court Met In Short Session On Tuesday

Union County Fiscal Court met in a short session Tuesday morning with only four items on the agenda.

The first agenda item to come before the magistrates was the second reading of an ordinance amendment clarifying language related to the county's special purpose vehicle ordinance. First reading of the amendment was held on December 22, cleaning up language as it relates to the 20-

mile usage regulations on some highways. The court approved second reading unanimously.

The court also heard a presentation from the county's IT director Jonathan Baird who presented information and costs of software upgrades for taxes, HR and the road department. According to Baird, he has met with a representative from Gov Track, a company that has a software that allows users to file

business taxes on line, submit HR paperwork on line and take care of road department paperwork.

In his presentation, Baird noted that it is difficult to find a software company that integrates multiple platforms, but Gov Track would benefit the county by streamlining paperwork for the office staff, the treasurer and the road department. Although there is a high upfront cost,

the annual fee to have

software for all three

entities is \$12,000,

slightly less than the county is paying for road department software now. Magistrates approved advertising for bids January 21 and 28 and opening bids at the court's February 10, meeting.

During Tuesday's session, the court also opened bids for request for proposals for the Hitesville Road Bridge project. Although three

companies submitted

proposals, only one of

those proposals includ-

ed the cost for the ser-

vices. Judge/Executive

Adam O'Nan asked the

court to take the pro-

posal under advisement

so Shawn Sheffer can

contact the bidders for

additional information.

Magistrates approved

O'Nan's request.

Before the meeting

adjourned claims were

approved as presented.

O'Nan also an-

nounced that he will

travel to Washington

DC later this week and

with the Kentucky Leg-

islature in session he

will be spending "a lot

of time in Frankfort"

to support KACo initia-

tives and other possible

legislation that could

impact the county. The

judge/executive also re-

ported that he has met

with Deaconess EMS

regarding the county's

concerns over response

time. He will provide

the court an update af-

ter his next meeting

with the agency.

With no other busi-

ness to discuss, the

meeting adjourned at

9:22, with the court's

next meeting set for

Tuesday, January 27,

at 9:00 a.m.

New Year Finds Miracle Of Peace

How many times have we lost something and fretted because finding it would be like looking for a needle in a haystack?

Over the years I have had my share of needles in a haystack, but have miraculously found them in a surprisingly short time. Albeit with the help of St. Anthony, but that haystack didn't turn out quite as large as I thought it was.

St. Anthony of Padua (1195-1231) is the patron saint of lost things, known for his powerful preaching and miracles, with the "lost things." Catholics pray to him for help finding physical items like keys, and wallets, as well as lost souls or spiritual direction.

Over the years he has found many things for me: keys lost on a beach, wallets, a missing credit/debit card, hearing aids, the diamond in my ring twice, and even my dustpan when

I absolutely thought I was going crazy. The dustpan was attached to the broom I was carrying around. I think he put it there without me seeing him do it. That dustpan was not on the broom the whole time.

Sometimes he is quick in giving me aid and sometimes he has me wait a little longer than I want to wait.

Whenever my brother died, I missed him sorely. After his funeral I started finding things in the shape of a heart. When I would work in the flower gardens, I would find a rock or two in the shape of a heart. I was always finding something in the shape of a heart. There were leaves, the shape of a cookie that should have been round, the first thing I saw was a whole potato shaped like a perfect heart. All things made me think of Raymond and smile.

Whenever my dad died, I started finding pennies randomly placed, on the sidewalks, in a jacket I hadn't worn for a while.

I knew my brother and dad were where they needed to be.

After that it made me think about my mother. She died in 1999 and shortly afterwards I asked her if she would send me a sign that she was okay. Not just any sign. I wanted a wheat penny dated 1936, the year she was born.

When I received a sign from my brother and dad right after they passed, in 2019 and in 2023, I went on a crazy guilt trip. I was sure it was all my fault. I never got a sign from my mother. During my teen-age years my mother and I battled and we weren't close.

After I became an adult and matured, things started changing in our relationship.

When I thought things were going well, she died of breast cancer. I was in my early 40s and she was in her early 60s. We never really had a closure. I prayed to God one day if she had forgiven me could she leave me a

sign. Not any sign. I still wanted a wheat penny dated 1936. I never got a sign.

I then added St. Anthony to my prayer. I asked him to find my mother and help me find the peace I wanted. I have prayed for her over the years, I asked her forgiveness, but never felt at peace.

The rest of the story. It was the morning of New Year's Eve, 2025. I sat at my desk catching up on paperwork, and maybe even thinking about decluttering the desk as my first resolution for the New Year.

The desk was a work in progress with paperwork piling up in front of me. Next to my stacked papers I noticed something in the shadow. It was a penny. I hadn't seen any loose change on my desk for a long time.

I picked it up. It

was a wheat penny. I wondered where it had come from. I turned it over thinking "could it be?" and there was the date, 1936. I got cold chills and tears came to

my eyes. I was literally shaking. In the 26 years my mother has been gone, I have seen very few wheat pennies and none dated 1936.

My first thought was I have been forgiven. St. Anthony has found her and given me the peace I have needed for so long.

May your 2026 be filled with miracles every day.
