first offense (two grams or more of methamphetamine), possession of marijuana, and possession of drug paraphernalia. Sentencing was set for Nov. 25.

Jayden Ray Soule was sentenced to two years in jail for possession of a controlled substance in the first degree, first offense (methamphetamine).

Eric Lynn Terry had a bench warrant issued for his arrest during a hearing on revoking his probation.

James M. Terry was sentenced to one year in jail for possession

of a controlled substance in the first degree, first offense (methamphetamine) and possession of drug paraphernalia.

Mary Belle Wethington was sentenced to two years in jail probated three years for public intoxication by a controlled substance excluding alcohol, possession of a controlled substance

in the first degree, first offense (methamphetamine), possession of marijuana, and possession of drug paraphernalia.

Joshua L. Dial had a bench warrant issued for his arrest in a show cause hearing on \$845 in unpaid fines, fees or court costs.

Two hours later, the jail called and reported that Wooten had thrown a bag of marijuana down the toilet and flushed it. Upon arrival, Harris spoke to Jail Deputy Tabitha Roberts who had searched Wooten inside the jail. Roberts told Harris that she had taken Wooten into the strip search room and while getting her clothing together, Wooten was messing with her bra. Roberts asked what she was doing and Wooten pulled out a baggie of marijuana. Roberts ordered her to drop the baggie several times, but Wooten instead threw it into the toilet and then flushed it.

Harris asked Wooten what happened and Wooten said she found marijuana in her pocket so she threw it into the

toilet and flushed it. The jail stated they had video footage of her confession and also audio of the incident.

- Gerald Jeff Popplewell, 49, of Willamstown, Kentucky, was arrested Oct. 20 for trafficking in a controlled substance in the first degree, second or subsequent offense (two or less grams of methamphetamine), trafficking in a controlled substance in the first degree, first offense (two or less grams of cocaine), disregarding a stop sign, operating a motor vehicle while under the influence of a controlled substance second offense, and possession of drug paraphernalia.

According to a citation written by Casey County Sheriff’s Deputy Austin Harris, at around 5:30 p.m. he was traveling on Wilson Ridge Road when he began following a blue car. The blue car turned onto Lower Brush

Creek Road but did not stop at the stop sign. Then it turned onto KY 49 but did not stop at the stop sign.

Harris then followed and initiated a traffic stop. He spoke to the driver, Popplewell, and explained the reason for the stop. He asked for information and sent it to dispatch. While waiting for dispatch to return information, Harris deployed K9 Nitro and ran the dog around the vehicle. The dog alerted on the driver’s side door by sitting down. Harris asked Popplewell if there were any illegal substances in the vehicle and he replied there was not.

Harris noted that Popplewell’s pupils were constricted and he asked him when the last time he used drugs and Popplewell stated that it was two days prior.

Harris had Popplewell stand in front of the vehicle while he searched. He found

a digital scales with meth residue on it. Deputy Jacob Atwood and Special Deputy Billy Duncan arrived shortly thereafter. Atwood stood with Popplewell, while Duncan assisted with the search.

Duncan located a welding glove. Inside the glove were a glass pipe and a pill bottle.

After reading Popplewell his rights, Harris asked what was inside the bottle. Popplewell stated that it was meth and cocaine.

Harris asked Popplewell to perform a field sobriety test and afterward believed he was impaired. Harris then placed Popplewell under arrest and transported him to the Casey County Hospital where blood was drawn. He then transported Popplewell to the Casey County Detention Center.

and hostility. We can agree those who lie are deceptive, but secretly hating them is not only hurting our soul but also hindering God’s divine appointments with His gospel of salvation to save them.
